- 2. The total amount payable by COUNTY to CONTRACTOR for all services performed during the period of July 1, 2015 to June 30, 2016 shall not exceed the sum of \$3,210, pursuant to the attached invoice.
- 3. If there is any conflict or inconsistency between the provisions of the Agreement, or this Amendment, the provisions of this Amendment shall govern. A copy of this Amendment shall be attached to the original Agreement. Except as provided herein, all other terms, conditions, provisions, entitlements and obligations of the original Agreement shall remain unchanged and unaffected by the Amendment and shall continue in full force and effect.
