WHEREAS, Commander Fabian M. Barrera was born in Salinas, California on May 25, 1964 and has resided in the City of Soledad for the past fifty-one years; and

WHEREAS, Commander Fabian M. Barrera has been married to Precila for the past twentynine years, spending quality time with their four girls Samantha, Sara, Sabrina and Sophia, their two boys Simon and Seth, their five foster children Raquel, Rafael, Marco, Sammy, Kimberly, and their grandchild Julius; and

WHEREAS, Commander Fabian M. Barrera was hired as a Deputy Sheriff on May 22, 1985 and received the Oath of Office from Sheriff David B. *Bud* Cook. He served during the terms of six Sheriffs; Sheriff D. B. *Bud* Cook, Sheriff Norman G. Hicks, Sheriff Gordon Sonné, Sheriff Michael J. Kanalakis, Sheriff Scott K. Miller, and Sheriff Steve Bernal; and

WHEREAS, in 1984, Commander Fabian M. Barrera attended the Alameda County Sheriff's Academy class in Dublin, California and in 2010 graduated from Hartnell Community College with an Associate of Arts degree in Administration of Justice; and

WHEREAS, Commander Fabian M. Barrera was promoted to the rank of Sergeant on July 7, 2002 by Sheriff Gordon Sonné, and the rank of Sheriff's Commander by Sheriff Kanalakis on January 8, 2005; and

WHEREAS, Commander Fabian M.
