WHEREAS, *Manny Solano*, Chief of Police, is said to retire on December 31, 2015, after completing 30 years of dedicated and outstanding law enforcement service; and

WHEREAS, *Manny Solano* and his family have been lifelong residents of the Elkhorn Road and Fruitland Avenue neighborhoods of North Monterey County; and, although Chief Solano works in the City of Watsonville he has been crucial in numerous incidents and events in the County of Monterey; and

WHEREAS, in October 17, 1989, *Manny Solano* rendered services as a First Responder during the devastation of the Loma Prieta Earthquake of 1989; and

WHEREAS, September 21, 1989, *Manny Solano* successfully investigated and dismantled one of the largest heroin and cocaine operations based out of a home at 1515 San Juan Rd in Monterey County seizing over 1 kilogram of heroin, 2 pounds of cocaine and numerous guns and weapons; and

WHEREAS, in March of 1995, *Manny Solano* served as Incident Commander during the tragic Pajaro Valley Flood of 1995, where he assisted in rescue and evacuation efforts and help bring Pajaro residents to safety, personally helped with clean up and recovery, and oversaw a fundraiser for flood victims by the producing the Pajaro Valley Flood of 1995 video documentary; and

WHEREAS, in 2007, *Manny Solano* was recognized and the recipient of the Pajaro Valley Man of Year Award; and

WHEREAS, *Manny Solano* served on the board of and continues to support the Pajaro Valley Rescue Mission and the needs of Pajaro homeless; and

WHEREAS, *Manny Solano* remains involved and supports the work of Monterey Bay Teen Challenge based in Pajaro; and

WHEREAS, *Manny Solano* and his wife, Megan, minister to the men and women of Monterey Bay Teen Challenge helping them overcome substance abuse and other life threatening issues; and

WHEREAS, *Manny Solano* has been a guest speaker at Soledad State Prison and helped with the re-entry back into society of many individuals to include community leaders such as Danny Contreras.
