AMENDMENT NO. 2 TO AGREEMENT BETWEEN COUNTY OF MONTEREY AND ERGOVERA ERGONOMIC CONSULTING

THIS AMENDMENT is made to the AGREEMENT for the provision of ergonomic analysis, training and consulting services for the office and industrial environments by and between **Deidre Rogers dba Ergovera Ergonomic Consulting**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY".

WHEREAS, the COUNTY and the CONTRACTOR entered into the original AGREEMENT on August 22, 2012; and

WHEREAS, the COUNTY and CONTRACTOR amended the AGREEMENT via Amendment No. 1, to extend the term by one year through August 31, 2016; and increased the AGREEMENT by \$30,000, from \$75,000, for a total amount not to exceed the sum of \$105,000; and.

WHEREAS, the COUNTY and CONTRACTOR hereby wish to amend the AGREEMENT by way of Amendment No. 2 to increase the amount by \$9,000 from \$105,000, for a total amount not to exceed the sum of \$114,000.

NOW THEREFORE, the COUNTY and CONTRACTOR hereby agree to amend the AGREEMENT as follows:

- 1. Section 4, "COMPENSATION AND PAYMENTS", Subsection 4.1, shall be amended by increasing the AGREEMENT by \$9,000, from \$105,000, for a total amount not to exceed the sum of \$114,000.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT as amended are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect, as set forth in the AGREEMENT.
- 3. A copy of the AMENDMENT No. 2 shall be attached to the original AGREEMENT executed by the COUNTY on August 22, 2012.
