## **AGREEMENT**

- 3. <u>Successors and Assigns</u>: This Assignment shall be binding on and inure to the benefit of Assignor and Assignee and their respective successors and assigns.
- 4. <u>Third Party Beneficiaries</u>: Except as expressly provided in this Section, no person other than the parties hereto shall have any right, benefit or obligation under this Assignment as a third-party beneficiary or otherwise.

- (i) <u>Headings</u> The headings in this Assignment are for convenience of reference only and are not part of the substance hereof.
- (ii) <u>Benefit</u> This Assignment shall be binding upon and inure to the benefit of the parties and their respective successors, assigns and, if applicable, heirs and administrators.

- (iii) Counterparts This Assignment may be executed in multiple originals and by counterpart.
- (iv) Governing Law This Assignment shall be construed under the laws of the State of California.
- (v) <u>Amendments</u> No alteration, amendment or modification hereof shall be valid, unless executed by an instrument in writing by the parties hereto with the same formality as this Assignment.
- (vi) <u>Further Assignments</u> Nothing in this Assignment shall imply any right to make further assignments of the Agreement other than in accordance with the Agreement.
