Upon motion of Supervisor Parker, seconded by Supervisor Phillips and carried by those members present, the Board of Supervisors hereby:

- a. Authorized the Deputy Purchasing Agent for Natividad Medical Center (NMC) to execute Master Agreements with AMN Healthcare Inc., Cirrus Holdings Inc., and Cross Country Staffing Inc. to provide Ancillary Registry Services as per RFP #9600-22, with an increase of \$400,000 to the aggregate spending limit for all Ancillary Agreements through June 30, 2015;
- b. Authorized the Deputy Purchasing Agent for Natividad Medical Center (NMC) to execute Amendment No. 1 to all of the Master Agreements for Ancillary Registry Services at NMC pursuant to RFP #9600-22 with C & A Industries Inc., Per Diem Staffing Systems Inc., Sonotemps Inc., SHC Services Inc., AMN Healthcare Inc., Cirrus Holdings Inc., Cross Country Staffing Inc., and Maxim Staffing Solutions Inc., to extend the term for one additional year, increasing the aggregate spending limit by an additional \$2,300,000 for the period July 1, 2015 through June 30, 2016, for a total aggregate amount not to exceed \$6,300,000 for all Ancillary Master Agreements; and
- c. Authorized the Deputy Purchasing Agent for NMC to execute future Amendments to the Agreement which do not significantly alter the scope of work and do not cause an increase to the total Agreement amount.

**AMENDMENT NO. 1
TO SERVICES AGREEMENT
BETWEEN AMN Healthcare Inc. AND
NATIVIDAD MEDICAL CENTER
FOR
ANCILLARY REGISTRY SERVICES**

This Amendment No. 1 to the Master Services Agreement per the Request for Proposals; RFP #9600-22 ("Agreement"), dated August 1, 2012 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and AMN Healthcare Inc. (hereinafter "CONTRACTOR"), with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for Ancillary Registry Services per RFP #9600-22 with a three year initial term and a total Agreement amount not to exceed \$3,600,000 for all contracts under the Master Agreement; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional twelve month period through June 30, 2016 to allow for services to continue with a \$2,700,000 increase for the extended term period and for a total Master Agreement amount of \$6,300,000 for all contracts under the Master Agreement.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

The Agreement is hereby amended on the terms and conditions as set forth in Original Agreement incorporated herein by this reference, except as specifically set forth below.

1. Section 5.1, "Term of Agreement" shall be deleted and amended to the following;


"The term of the Agreement is August 1, 2012 through June 30, 2016 with the option to extend the Agreement for one (1) additional one (1) year period at the end of the term. NMC is not required to state a reason if it elects not to renew this Agreement."

2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement
3. A copy of this Amendment No. 1 shall be attached to the Original Agreement.
