AMENDMENT NO. 8 TO SERVICES AGREEMENT BETWEEN CREDIT CONSULTING SERVICES, INC. (CCS) AND NATIVIDAD MEDICAL CENTER FOR DEBT COLLECTION SERVICES

This Amendment No. 8 to the Services Agreement ("Agreement") which was effective on August 1, 2007 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and Credit Consulting Services, Inc. (CCS), (hereinafter "CONTRACTOR"), with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for Collection Services with a term August 1, 2007 through June 30, 2009 and a total Agreement amount not to exceed \$1,000,000; and

WHEREAS, NMC and CONTRACTOR renewed and amended the Agreement via Renewal and Amendment No. 1 to extend the term for an additional twelve month period through June 30, 2010 and to add an additional \$700,000 thereby increasing the total agreement amount to \$1,700.000; and

WHEREAS, NMC and CONTRACTOR renewed and amended the Agreement via Renewal and Amendment No. 2 to extend the term for an additional twelve month period through June 30, 2011, and to add an additional \$700,000 thereby increasing the total agreement amount to \$2,400,000; and

WHEREAS, NMC and CONTRACTOR renewed and amended the Agreement via Renewal and Amendment No. 3 to extend the term for an additional twelve month period through June 30, 2012 and to add an additional \$700,000 thereby increasing the total agreement amount to \$3,100,000; and

WHEREAS, NMC and CONTRACTOR renewed and amended the Agreement via Renewal and Amendment No. 4 to extend the term for an additional twelve month period through June 30, 2013; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on July 1, 2013 via Amendment No. 5 to extend the term for an additional twenty four month period through June 30, 2015; and

WHEREAS, NMC and CONTRACTOR renewed and amended the Agreement via Renewal and Amendment No. 6 to extend the term for an additional twelve month period through June 30, 2016; and

WHEREAS, NMC and CONTRACTOR amended the Agreement via Amendment 7 to extend the term for an additional three month period through September 30, 2016 and to add an additional \$300,000 thereby increasing the total agreement amount to \$3,400,000.

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to add an additional \$300,000 thereby increasing the total agreement amount to \$3,700,000.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in Original Agreement and in Renewal and Amendment No. 1, Renewal and Amendment No. 2, Renewal and Amendment No. 3, Renewal and Amendment No. 4, Amendment 5, Renewal and Amendment No. 6, and Amendment No. 7 incorporated herein by this reference, except as specifically set forth below.

1. The last sentence of Section 2 "PAYMENTS BY COUNTY" shall be amended to the following; "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$3,700,000."

Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 8 and shall continue in full force and effect as set forth in the Agreement and Renewal and Amendment No. 1, Renewal and Amendment No. 2, Renewal and Amendment No. 3, Renewal and Amendment No. 4, Amendment 5, Renewal and Amendment No. 6, and Amendment No. 7.
- 3. A copy of this Amendment No. 8 shall be attached to the Original Agreement.
- 4. This Amendment No. 8 is effective when signed by both NMC and CONTRACTOR.
