## AMENDMENT NO. 1 TO SERVICES AGREEMENT BETWEEN JANE FINNEY, CLS, MBA, CPHQ, CPPS AND NATIVIDAD MEDICAL CENTER FOR

## PROFESSIONAL CONSULTING SERVICES FOR DELIVERY SYSTEM INCENTIVE PROGRAM

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on November 9, 2015 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and Jane Finney, CLS, MBA, CPHQ, CPPS. (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

## RECITALS

WHEREAS, the Agreement was executed for professional consulting services for Delivery System Incentive Program with a term November 9, 2015 through November 1, 2016 and a total Agreement amount not to exceed \$100,000; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional one (1) year period through November 1, 2017 to allow for services to continue with a \$100,000 increase for a total Agreement amount of \$200,000.

## AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement incorporated herein by this reference, except as specifically set forth below.

- 1. Paragraph titled, "PAYMENTS BY NMC" shall be amended to the following:
  "NMC shall pay the CONTRACTOR in accordance with the payment provisions set forth in EXHIBIT A, subject to the limitations set forth in this Agreement. The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$200,000."
- 2. The first sentence of the <u>Paragraph titled</u>, "TERM OF AGREEMENT" shall be amended to the following:
  - "The term of this Agreement is from November 9, 2015 through November 1, 2017 unless sooner terminated pursuant to the terms of this Agreement."
- 3. Except as provided herein, all remaining terms, conditions and provisions of the Original Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 4. A copy of this Amendment No. 1 shall be attached to the Original Agreement.
