
# Project Overview

- Between 30,000 and 50,000 Monterey County Residents have no health insurance.
  - http://www.countyhealthrankings.org/app/california/2015/measure/factors/85/data
- The Monterey County Health Department (MCHD) and other safety net clinics provide Primary Care, but no funding was available for other critical services. Needed medical diagnostic tests and treatments were delayed because of the patient's inability to pay for them.
- On September 15, 2015 the Monterey County Board of Supervisors set aside \$500,000 for a pilot project to provide specific pharmacy, laboratory, and radiology services for this population. (Monterey County residents who do not qualify for health insurance)
- The Monterey County Board of Supervisors received quarterly updates on the Pilot project on February 2, 2016 and May 17<sup>th</sup> 2016.






### Pilot Project for the Remaining Uninsured Current Status – 1,218 people enrolled as 9/15/2016





- Stopped counting patients under 19 starting in July.
- 40 50 patients unenrolled monthly since June. (verified over income limit, has OHC, etc.)














