WHEREAS, on December 06, 2011, the Board of Supervisors approved Board Resolution No. 11-377 authorizing the Monterey County Sheriff to sign and submit an application for a local jail facility construction grant in the amount of \$80 Million, and made other necessary and appropriate findings and declarations supporting the construction grant application;

WHEREAS, the application for a 576- maximum-security-bed housing addition was submitted and found worthy of funding at the Corrections Standards Authority (CSA) Board Meeting in September 12, 2013;

WHEREAS, the Board of Supervisors on August 28, 2012, approved Board Resolution No. 12-243 approving the existing Jail site, located at 1410 Natividad Road, Salinas, CA, as the proposed site for a Jail Housing Addition facility to comply with the site assurance requirements pursuant to Phase II Local Jail Construction Financing Program;

WHEREAS, the Board of Supervisors on November 5, 2013, approved Board Resolution No. 13-1152 approving submission of revised Project Scope, Cost, and Schedule by the Monterey County Sheriff to the Board of State and Community Corrections (BSCC) for approval;

WHEREAS, BSCC approved the revised project Scope, Cost, and Schedule on July 30, 2014; and

WHEREAS, the County and Lionakis Architects have now completed preparation of the Working Drawings (Plans and Specifications) for BSCC approval for the construction of the Jail Housing Addition facility; and

WHEREAS, approval of this recommended resolution provides for the required submission of Working Drawings (Plans and Specifications) to the BSCC to seek State approval to Proceed to Bid.
