Good morning Sgt. Caldwell,

We have received a request from Chiquita Walker representing Mr. Stan Suarez for a Public Convenience or Necessity (PCN) at the above-mentioned location. The establishment is a mini-mart to a gas station located in the County's jurisdiction off of Hwy. 101 South and Silliman Rd. They currently have a Type 20-Off-Sale Licence (Beer and Wine) and are proposing to surrender this License for a Type 21- Off-Sale (Beer, Wine and Liquor).
