Decision: The Zoning Administrator directed staff to come back with a resolution of approval and to investigate the following items in discussions with the applicant: moving the house back away from the Cypress Tree, moving the garage doors without exterior parking encroaching in the area needed to meet Fire Department requirements, and the possibility of moving the terraces back in order to protect as much of the forest ground. The Zoning Administrator continued the hearing to February 23, 2017.
