WHEREAS, on February 7, 2017, the Monterey County Water Resource Agency's (Agency) authorized a multi-year agreement with the State Department of Water Resources (DWR) for the receipt of up to \$10 million in state grant funds, effective September 13, 2016, on a reimbursement basis for the Interlake Tunnel and San Antonio Spillway Modification Project (Project); and

**WHEREAS**, the Agency entered into three Reimbursement and Funding Agreements whereby the County of Monterey granted \$3 million to the Agency, subject to reimbursement to the County, for development of the Project (County Agreements); and

WHEREAS, the Agency wishes to create a new fund to track revenue and appropriations of up to \$2,000,000 based on the FY 2016-17 Project work plan to be submitted to DWR for reimbursement, including the existing appropriation of \$1,161,635 in remaining balance in the fiscal year 2016-17 budget from the County Agreements to the new Project Fund for greater ease and tracking of Project funding and expenditures, and reimbursement of State Grant Funds.
