WHEREAS, On December 15, 2015 and September 9, 2016, the Board of Supervisors approved increases to place the Physician Assistant salary range at the same rate as the Nurse Practitioner II due to a classification and compensation study conducted by Cooperative Personnel Services (CPS); and

WHEREAS, The Human Resources Department conducted a new wage analysis, reviewed the classification study conducted by CPS, and the items taken forward to the Board of Supervisors in 2015 and 2016; and

WHEREAS, the Human Resources Department recommends the salary of the Physician Assistant classification be increased to match that of the Nurse Practitioner II until a recommendation is brought forward that will formally align the salaries of these two classifications; and

WHEREAS, the Human Resources Department recommends the classifications of Physician Assistant I and II be abolished; and

WHEREAS, the actions require the Personnel Policies and Practices Resolution No. 98-394 Appendices A and B be amended.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey hereby resolves to approve the following:

- Appendix A of Personnel Policies and Practices Resolution No. 98-394 is amended to adjust the salary range of the Physician Assistant classification as indicated below, effective February 4, 2017; and
