WHEREAS, the Department of Social Services is seeking to amend the contract with the Franciscan Workers of Junipero Serra to add \$200,000 to continue extended operations and case management services at Dorothy's Place for the remaining five (5) months of Fiscal Year 2016-17; and

WHEREAS, the increased funding will allow for continued progress in housing chronically homeless community members, and will be provided in conjunction with the Whole Person Care pilot program; and

WHEREAS, certified public expenditures to match Federal Whole Person Care waiver funds can be made available by transferring General Fund Contributions from the Department of Social Services operational budget to the Community Programs budget;

WHEREAS, the contract with the Franciscan Workers of Junipero Serra and matching certified public expenditures are paid from the Community Programs budget requiring increased appropriations and revenues; and,
