Upon motion of Supervisor Potter, seconded by Supervisor Armenta and carried by those members present, the Board of Supervisors hereby:

- a. Authorized the Deputy Purchasing Agent for Natividad Medical Center (NMC) or his designee to execute Amendment No. 1 to the agreement (A-12637) with Intelligent Medical Objects, Inc. (IMO) for software subscription, software implementation, migration, and software maintenance services at NMC, extending the agreement an additional twelve (12) month period (January 28, 2017 through January 27, 2018) for a revised full agreement term of January 28, 2014 through January 27, 2018, and adding \$31,600 for a revised total agreement amount not to exceed \$141,400; and
- b. Authorized the Deputy Purchasing Agent for NMC or his designee to execute up to three (3) future amendments to the agreement which do not significantly alter the scope of work and do not cause an increase of more than ten percent (10%) of the original cost of the agreement per each amendment.

WHEREAS, County of Monterey, a political subdivision of the State of California, on behalf of Natividad Medical Center ("Client"), and Intelligent Medical Objects, Inc. ("IMO") (collectively the "Parties" or individually "Party") entered into a License Agreement dated January 28, 2014 ("Agreement"); and

WHEREAS, the Agreement provided the option to renew the Agreement upon mutual consent of the parties; and Client and IMO wish to exercise the renewal option and extend the Agreement for an additional Term.

NOW THEREFORE, in consideration of the foregoing recitals, it is hereby agreed by and between the parties as follows:

1. The Agreement is hereby renewed for a one (1) year period commencing on January 28, 2017 and terminating on January 27, 2018 ("Renewal Term").
2. The annual fee will remain \$1,000 for support and maintenance, plus \$30,600 for the IMO subscription fee according to current NPR, for a total cost of \$31,600 to extend the Agreement and a revised Agreement amount of \$141,400.
3. All terms used in this Amendment that are not otherwise defined shall have the respective meanings ascribed to such terms in the Agreement. All other terms and conditions of the Agreement that are not hereby amended are to remain in full force and effect.
