

INTER-AGENCY AGREEMENT  
Monterey County Victim Services Project  
CalOES VOCA XC16 Grant FY16-18

This Inter-Agency Agreement stands as evidence that the Monterey County Administrative Office/Office of Community Engagement and Strategic Advocacy (OCESA) and the Monterey County Health Department intend to work together towards the mutual goal of providing maximum available assistance for victims of crime residing in Monterey County. Both agencies believe that continuation of the Monterey County Sexual Assault Response Team as funded by the California Office of Emergency Services Victims of Crime Act XC 16 grant. To this end, each agency agrees to participate in the program as follows:

**Terms of Agreement**

Monterey County Health Department:

1. The Monterey County Sexual Assault Response Team will closely coordinate the following services with the OCESA through:
  - a. Provide training and credentialing of five forensic examiners;
  - b. Experienced examiners will be proctored for two exams each for a total of ten proctored exams, following all state evidentiary collection requirements;
  - c. New examiners' attendance of the California Clinical Forensic Medical Training Center courses for Pediatric and Adult forensic exams for the two courses after receiving proof of completion of the required didactic training;
  - d. Provide direct services to victims and suspects in the form of a sexual assault evidentiary exam;
2. The Monterey County Sexual Assault Response Team agrees to provide information to the OCESA staff on victim services and other information and resources provided to victims. The Program further agrees to provide referral information to victims and significant others who may benefit from Victim Services provided by other grantee organizations.
3. Reporting and service invoice/billing requirements include quarterly and annual or as needed basis will be provided to the OCESA staff for grant reporting. Grantee meetings will be conducted between the OCESA and the Monterey County Sexual Assault Response Team staff on an as needed basis to discuss strategies, time tables and implementation of mandated services.
4. This agreement will be in effect for a period of 2 years unless one or both parties terminate the agreement.

Office of Community Engagement and Strategic Advocacy:

1. Allocate and provide a total of **\$7,750** in VOCA XC16 funding to the Monterey County Health Department's **Monterey County Sexual Assault Response Team** for training and credentialing of forensic examiners. Said funds will be disbursed on a quarterly basis upon presentation and verification of receipts, time cards, or other proofs of expenditure and receipt of CalOES VOCA XC16 funds reimbursement.

2. Coordinate grantee meetings between the OCESA and the Monterey County District Attorney's Victim Witness program staff on an as needed basis to discuss strategies, time tables and implementation of mandated services.
3. Communicate regularly with the Victim Witness Program Manager regarding the victim services provided with support of the CalOES VOCA XC16 funds grant requirements.

### **CONFIDENTIALITY**

To the extent permitted by law, both the Office of Community Engagement and Advocacy and Health Department agree to share information regarding services provided by this Inter-Agency Agreement. Information pertaining to the victim's history shall be used only to gain an understanding of the needs of victims and to improve the planning, delivery and evaluation of services. The sharing of information related to specific case histories, as permitted by law, is deemed essential to interagency collaboration.

### **EFFECTIVE DATE OF AGREEMENT:**

This Inter-Agency Agreement shall become effective from July 1, 2016 and will terminate on June 30, 2018. If funding is available for subsequent years, this agreement will be reviewed and may be updated or revised by mutual consent. This agreement may be terminated by either party upon (30) days advance written notice to the other party.

We, the undersigned, as authorized representatives of the Monterey County Administrative Office/Office of Community Engagement and Strategic Advocacy and the Monterey County Health Department do hereby approve this document.
