**AMENDMENT NO. 3
TO SERVICES AGREEMENT
BETWEEN SOLIANT HEALTH INC., AND
NATIVIDAD MEDICAL CENTER
FOR
TEMPORARY STAFFING SERVICES FOR NMC PHARMACY**

This Amendment No. 3 to the Services Agreement ("Agreement"), dated April 15, 2012 is entered into by and between the County of Monterey, on behalf of **Natividad Medical Center (hereinafter "NMC")**, and **Soliant Health, Inc., (hereinafter "CONTRACTOR")**, with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for CONTRACTOR to provide temporary staffing services for NMC's Pharmacy with a one year term and a total Agreement amount not to exceed \$100,000; and

WHEREAS, NMC and CONTRACTOR previously amended the Agreement effective April 15, 2013 via Amendment No. 1 to extend the term through to June 30, 2013 and to add \$100,000 to the total Agreement amount; and

WHEREAS, NMC and CONTRACTOR previously amended the Agreement effective July 1, 2013 via Amendment No. 2 to extend the term an additional two (2) year period through to June 30, 2015 and to add \$200,000 to the total Agreement amount; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional one (1) year period through June 30, 2016 with no additional cost increase to the total Agreement amount.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Agreement and in Amendment No 1 and in Amendment No. 2, except as specifically set forth below.

1. Paragraph 2 titled "TERM OF AGREEMENT", shall be amended to the following;
"The term of this Agreement is April 15, 2012 through June 30, 2016 unless sooner terminated pursuant to this Agreement."
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and Amendment No 1 and Amendment No. 2 are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect.
3. The effective date of this Amendment No. 3 shall be July 1, 2015.
4. A copy of this Amendment No. 3 shall be attached to the Original Agreement.
