AMENDMENT NO. 3 TO AGREEMENT BETWEEN COUNTY OF MONTEREY AND URBAN PARKS CONCESSIONAIRES, DBA MONTEREY LAKES RECREATION COMPANY

THIS AMENDMENT NO. 3 to the Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Urban Parks Concessionaires, A California Corporation, DBA Monterey Lakes Recreation Company (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into an Agreement with County on May 17, 2016 (hereinafter, "Agreement") to provide lake resort management services at Lake San Antonio and Lake Nacimiento (hereinafter; "Services"); and

WHEREAS, Agreement was amendment by the Parties on July 19, 2016 to extend the term through October 31, 2017; and

WHEREAS, Agreement was amended by the Parties on July 27, 2016 to add additional language to the Mutual Indemnification Provisions of the Agreement relating to Quagga Mussel inspections; and

WHEREAS, County has a continued need for Services at Lake San Antonio and Lake Nacimiento, to allow the County time to develop a Request for Proposals document for long-term resort management; and

WHEREAS, the Parties wish to further amend the Agreement to extend the term for two (2) additional years through October 31, 2019.

NOW, THEREFORE, for valuable consideration, the sufficiency of which is hereby acknowledged, County and CONTRACTOR agree as follows:

- 1. The term of this Agreement is from May 17, 2016 through October 31, 2019.
- 2. All other terms and conditions of the Agreement remain unchanged and in full force.
- 3. This Amendment No. 3 and all previous amendments shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
- 4. The recitals to this Amendment No. 3 are incorporated into the Agreement and this Amendment No. 3.
