# FOURTH AMENDMENT TO PROFESSIONAL AND CALL COVERAGE SERVICES <u>AGREEMENT</u>

THIS FOURTH AMENDMENT TO PROFESSIONAL AND CALL COVERAGE SERVICES AGREEMENT (the "Amendment") is made and entered into as of July 1, 2017, by and between COUNTY OF MONTEREY ("County") on behalf of NATIVIDAD MEDICAL CENTER ("Hospital"), and ALLEN RADNER, M.D., an individual ("Contractor") with respect to the following:

## **RECITALS**

- A. County owns and operates Hospital, a general acute care teaching hospital facility located in Salinas, California and various outpatient clinics, including Natividad Immunology Division Outpatient Clinic (the "Clinic") under its acute care license.
- B. Contractor and Hospital have entered into that certain Professional and Call Coverage Services Agreement dated effective July 1, 2011, as amended effective July 1, 2012, July 1, 2013, and July 1, 2015 (collectively, the "Agreement") pursuant to which Contractor provides professional consultation and treatment in the Specialty to Clinic Patients.
- C. Hospital and Contractor desire to amend the Agreement to extend the term an additional twenty-four (24) months, to amend the compensation exhibit and to add One Hundred Eighty Thousand Dollars (\$180,000) to the aggregate amount payable for Services provided during the extended term.

## **AGREEMENT**

IN CONSIDERATION of the foregoing recitals and the mutual promises and covenants contained herein, Hospital and Contractor agree as follows:

- 1. **Defined Terms**. Capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Agreement.
- 2. <u>Section 2.1</u>. Section 2.1 to the Agreement is hereby amended and restated to read in its entirety as follows:
  - **"2.1 <u>Compensation.</u>** Hospital shall pay to Contractor the amount determined in accordance with <u>Exhibit 2.1</u> (the "Compensation"), upon the terms and conditions set forth therein. The total amount payable by Hospital to Contractor under this Agreement shall not exceed the aggregate amount of Seven Hundred Twenty Thousand Dollars (\$720,000) during the term of this Agreement."
- 3. <u>Exhibit 2.1</u>. Exhibit 2.1 to the Agreement is hereby replaced in its entirety and incorporation by this reference with the attached <u>Exhibit 2.1</u>.

- 4. <u>Section 5.1</u>. Section 5.1 to the Agreement is hereby amended and restated to read in its entirety as follows:
  - "5.1 <u>Term.</u> This Agreement shall become effective on July 1, 2011 (the "Effective Date"), and shall continue until June 30, 2019 (the "Expiration Date"), subject to the termination provisions of this Agreement."
- 5. <u>Counterparts</u>. This Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
- 6. <u>Continuing Effect of Agreement</u>. Except as herein provided, all of the terms and conditions of the Agreement remain in full force and effect from the Effective Date of the Agreement.
- 7. **Reference**. After the date of this Amendment, any reference to the Agreement shall mean the Agreement as amended by this Amendment.

## Exhibit 2.1

#### COMPENSATION

### 1. **Professional Services.**

, ,

- (a) Hospital shall pay to Contractor the amount of Seven Thousand Five Hundred Dollars (\$7,500) per month for those Services rendered by Contractor twenty-four (24) hours per day, seven (7) days per week under this Agreement ("Monthly Professional Services"); provided, however, that Contractor is in compliance with the terms and conditions of this Agreement.
- (b) In the event that Contractor does not provide the Monthly Professional Services under the terms and conditions set forth in Section 1(a) of this Exhibit 2.1, Contractor shall submit a monthly invoice for the following services:
  - i) <u>Clinic Services</u>. Hospital shall pay to Contractor an amount equal to Five Hundred Dollars (\$500) per Half-Day Clinic for Professional Services provided at the Clinic (the "Clinic Services") provided by Contractor. For purposes of this Agreement, a "Half-Day Clinic" shall mean a minimum of four (4) hours per day in the Clinic providing Clinic Services.
  - ii) <u>Infectious Disease Grand Rounds ("ID Rounds")</u>. Hospital shall pay to Contractor an amount equal to Two Hundred Fifty Dollars (\$250) for ID Rounds provided by Contractor. For purposes of this Agreement, ID Rounds shall be a minimum of two (2) hours each.
  - iii) <u>Coverage Services</u>. Hospital shall pay to Contractor an amount equal to Four Hundred Dollars (\$400) per twenty-four (24) hour period for Coverage Services provided pursuant to this Agreement.

Notwithstanding any other provision in this Agreement, the aggregate compensation under this Section 1(b) shall not exceed Seven Thousand Five Hundred Dollars (\$7,500) per month.

2. <u>Timing</u>. Hospital shall pay the compensation due for Services performed by Contractor after Contractor's submission of the monthly invoice of preceding month's activity and time report in accordance with this Agreement; <u>provided</u>, <u>however</u>, that if Contractor does not submit an invoice and time sheet within sixty (60) days of the end of the month during which Services were performed, Hospital shall not be obligated to pay Contractor for Services performed during that month. The County of Monterey Standard Payment Terms for contracts/PSAs and paying invoices is "30 days after receipt of the certified invoice in the Auditor-Controller's Office".
