Dear Legislative Committee:

On behalf of the City of Seaside, I am urging you to reject the Governor's budget proposal to eliminate the California Gang Reduction, Intervention, and Prevention (CalGRIP) Program.

The City of Seaside's Youth Violence Prevention Program was awarded Cal Grip funding in 2015. We were awarded 1.3 million dollars over the course of 3 years. As a part of the grant contract, we also agreed to match those funds dollar for dollar.

We used our funding to establish the Seaside Youth Resource Center (SYRC) which offers services to 10 to18 year olds, with a focus on families, at risk youth, youth on probation, and youth involved with gangs. Referrals to the Youth Resource Program are made by parents, teens, teachers, law enforcement officials, truancy courts, school counselors, probation, social services and others.

Through the SYRC, the services for youth and families have been carried out through a variety of programs, and collaborations with several County and non-profit agencies (community based organizations). These agencies (with Cal Grip funding) were able to provide free services, including prevention and early intervention services based on the individual's needs and goals.

The impact of the Cal Grip program being eliminated from the Governor's budget will be felt in Seaside for generations. Youth and families will lose their access to free services to help with the many challenges they currently face daily.

It is for these said reasons, that The City of Seaside urges you and your Committee to reject the Governor's budget proposal.

# **Re: CalGRIP Elimination - OPPOSE**

Dear Chairwoman Skinner:

On behalf of the Monterey County Sheriff's Office, I am urging you to reject the Governor's budget proposal to eliminate the California Gang Reduction, Intervention, and Prevention (CalGRIP) Program.

The City of Seaside's Youth Violence Prevention Program was awarded Cal Grip funding in 2015. They were awarded 1.3 million dollars over the course of 3 years. The City of Seaside used a portion of this funding to establish the Seaside Youth Resource Center (SYRC) which offers services to 10 to 18 year olds, with a focus on families, youth at risk, youth on probation, and youth involved with gangs. Referrals to the Youth Resource Program are made by parents, teens, teachers, law enforcement officials, truancy courts, school counselors, probation, social services and others.

Through the SYRC, the services for youth and families have been carried out through a variety of programs, and collaboration with several County and non-profit agencies. Our agency with Cal Grip funding is able to provide free services that include prevention and early intervention services based on the individual's needs and goals. Partnering with community-based organizations is critical to addressing the violence associated with criminal street gangs. A collaborative and multi-faceted approach is absolutely essential to reducing gang violence and the impact of such violence on our communities.

The impact of the Cal Grip program being eliminated from the Governor's budget will be felt for generations. Youth and families in Seaside and Monterey County will lose access to free services that help youth and families cope, and guide them through the difficult challenges they currently face on a daily basis.

It is for these reasons, that the Monterey County Sheriff's Office urges you and your Committee to reject the Governor's budget proposal that would eliminate the CalGRIP program.
