WHEREAS, For FY 2017-18, RMA developed a standardized project review and scoring criteria process for unfunded projects; and

WHEREAS, On March 6, 2017, RMA presented the updated scoring criteria and process to the Capital Improvement Committee (CIC); and

WHEREAS, The CIC provided support on consent for the process; and

WHEREAS, On April 27, 2017, the CIC provided direction regarding recommended project priorities for unfunded projects included in the draft CIP; and

WHEREAS, On April 28, 2017, the Budget Committee (BC) supported the approval of the FY 2017-18 capital funding for consideration in the Annual Budget, and requested that RMA return at a later date to review potential available funding for priority unfunded projects as recommended by the CIC; and

WHEREAS, On May 10, 2017 the Planning Commission (PC) passed a resolution determining that the CIP conforms to and is consistent with the 2010 Monterey County General Plan or the Local Coastal Program and 1982 General Plan as applicable, and recommended that the priority of CIP projects be reviewed in the context of Level of Service deficiencies identified in the 2010 General Plan Environmental Impact Report.
