### AMENDMENT #8 TO AGREEMENT A-12200 BY AND BETWEEN THE COUNTY OF MONTEREY & CALIFORNIA FORENSIC MEDICAL GROUP, INC. RETROACTIVE TO JULY 1, 2017

**THIS AMENDMENT** is made to the AGREEMENT for adult inmate medical services at the Monterey County Jail by and between **CALIFORNIA FORENSIC MEDICAL GROUP, INC.**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

**WHEREAS**, the County and CONTRACTOR first entered into the AGREEMENT on March 27, 2012, by board action, and subsequently amended the AGREEMENT on June 11, 2013, with Amendment #1, on September 14, 2014 with Amendment #1A, on February 1, 2015 with Amendment #2, on June 26, 2015 with Amendment #3, on June 20, 2016 with Amendment #4, on October 5, 2016 with Amendment #5, on February 15, 2017 with Amendment #6; and on June 27, 2017 with Ratification Amendment #7; and

**WHEREAS**, the AGREEMENT expired, subject to its terms on June 30<sup>th</sup>, 2017; an

**WHEREAS**, the County and CONTRACTOR wish to amend the AGREEMENT retroactive to July 1st, 2017; and

**WHEREAS**, Probation has given CONTRACTOR the required notices to end its legal commitment on sections of the AGREEMENT (Scope of Work, Section 2.2.3 and 2.2.4, Juvenile Service Locations, Exhibit 1B Scope of Work for Juvenile Detention and Attachment A-Price Proposal for Monterey County Inmate Health Services for Juvenile Detention facility; and

**WHEREAS**, the County and CONTRACTOR wish to further amend the AGREEMENT to extend the AGREEMENT for an additional three (3) month period to finalize contract negotiations.

**NOW THEREFORE**, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner retroactive to July 1, 2017:

1. **Section 3.1, "TERM OF AGREEMENT"**, shall be amended by removing, "The term of this Agreement is from April 1, 2012 to June 30, 2017, unless sooner terminated pursuant to the terms of this Agreement", and replacing it with, "The term of this Agreement is from April 1, 2012 to September 30, 2017, unless sooner terminated pursuant to the terms of this Agreement".
2. **Sections 2.2.3 and 2.2.4, "SCOPE OF WORK"** shall be amended by removing sections in their entirety.

5. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
6. A copy of the Amendment shall be attached to the original AGREEMENT executed by the County on March 27, 2012.
