


THE LAND REFERRED TO HEREIN BELOW IS SITUATED IN THE UNINCORPORATED AREA, COUNTY OF MONTEREY, STATE OF CALIFORNIA AND IS DESCRIBED AS FOLLOWS:

All that parcel of land being in a portion of the Southwest Quarter of Section 27, Township 23 South, Range 9 East, Mount Diablo Meridian, in the County of Monterey State of California, said parcel being more particularly described as follows:

Commencing at the West 1/4 corner of said Section 27, said corner being also noted on map filed for record in the Office of the Monterey County Recorder in Book 8 of Surveys, at Page 16 and running from the West 1/4 corner, South $01^{\circ} 47'$ West 686.18 feet along the West line of said Section 27 to the true point of beginning; thence leaving said West line and running South $88^{\circ} 47' 28''$ East, 2375.21 feet to a point of the West line of Pleyto Road, a 60 foot wide county road; thence running Southwesterly along said Westerly line of said Pleyto Road, the following courses:

South $35^{\circ} 55' 35''$ West., 191.43 feet;

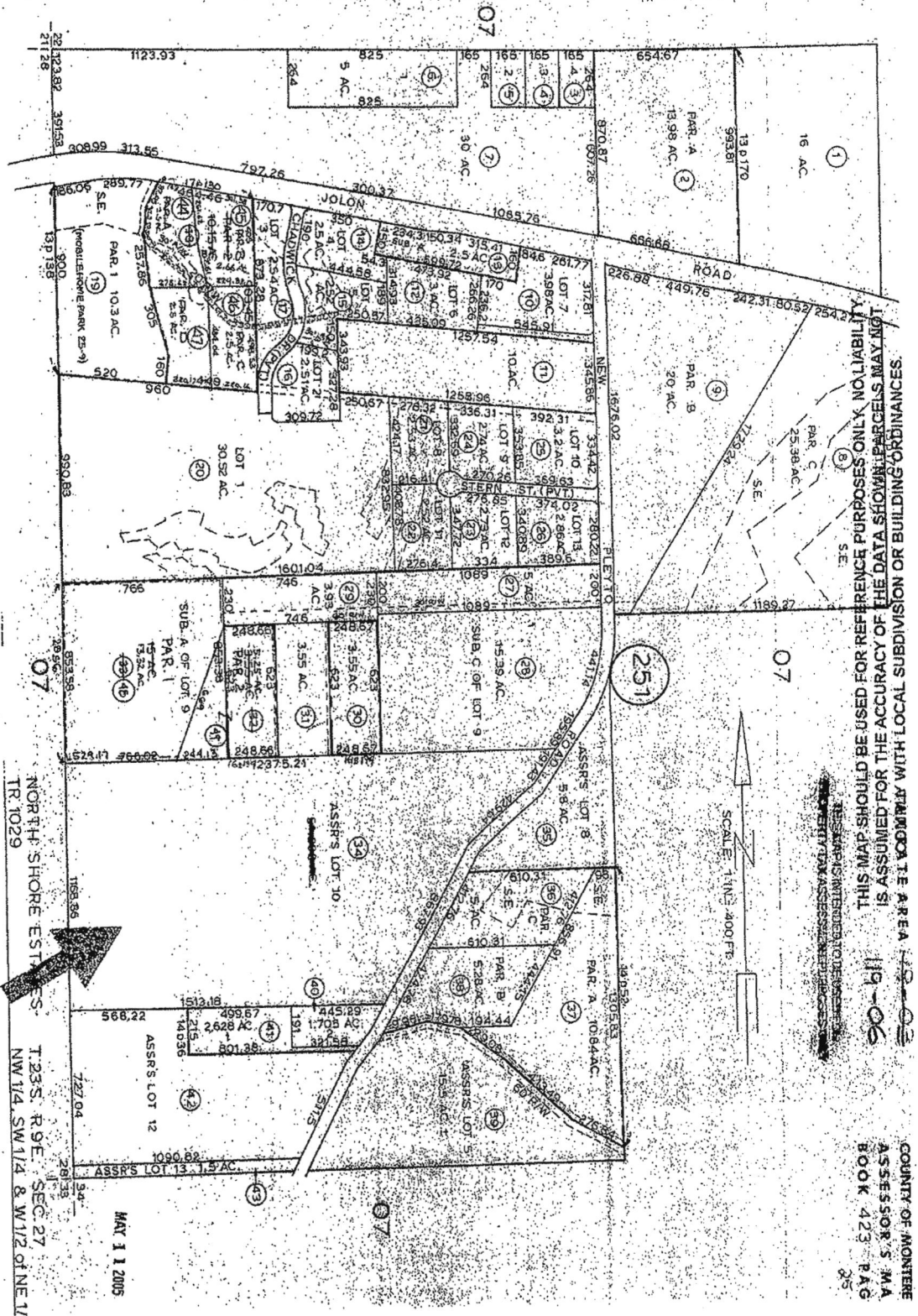
South $51^{\circ} 11' 17''$ West, 429.64 feet;
