Adopted Resolution 17-245 approving a budget amendment for the Monterey County Water Resources Agency's Fiscal Year 2016-17 Adopted Budget to modify the Agency's annual budget transfer of \$ 3,227,545 from Fund 119 - Water Resources - Zone No. 6 special assessment revenue to allocate as follows: \$843,340 to Fund 131 - CSIP Operating Fund, \$549,205 to Fund 132 - SVRP Operating Fund, and \$1,835,000 to Fund 303 - CSIP Debt Service Fund. Also transfer the Rate Stabilization Reserve of \$1,500,000 from Fund 303 - Debt Service Fund Unassigned Fund Balance to Fund 131 CSIP Operating Fund balance.

- Authorized the Auditor-Controller's Office to amend the Water Resources Agency FY 2016-17 Adopted Budget for Fund 119 - Water Resources - Zone #6 to increase appropriation with object code 7614 Operating Transfer Out (119-9300-8267-WRA009-7614) for total of \$3,227,545 financed by Special Assessments revenue source 5415 (119-9300-8267-WRA009-5415) (4/5th vote required) and;
- b. Authorized the Auditor-Controller's Office to amend the Water Resources Agency FY 2016-17 Adopted Budget for Fund 131 - CSIP Operating Fund to increase revenue source in Operating Transfers In account 5940 (131-9300-8267-WRA020-5940) for total of \$843,340 (4/5th vote required) and;
- c. Authorized the Auditor-Controller's Office to amend the Water Resources Agency FY 2016-17 Adopted Budget for Fund 132 - SVRP Operating Fund to increase revenue source in Operating Transfers In account 5940 (132-9300-8267-WRA021-5940) for total of \$549,205 (4/5th vote required) and;
- d. Authorized the Auditor-Controller's Office to amend the Water Resources Agency FY 2016-17 Adopted Budget for Fund 303 - CSIP Debt Service Fund to increase revenue source in Operating Transfers In account 5940 (303-9300-8267-WRA025-5940) for total of \$1,835,000 (4/5th vote required) and;
- e. Authorized the Auditor-Controller's Office to amend the Water Resources Agency FY 2016-17 Adopted Budget for Fund 303 - CSIP Debt Service Fund to transfer \$1,500,000 Unassigned Fund Balance 303-3101 (4/5th vote required) and;
- f. Authorized the Auditor-Controller's Office to amend the Water Resources Agency FY 2016-17 Adopted Budget for Fund 131 - CSIP Operating Fund to increase revenue source in Operating Transfers In account 5940 (131-9300-8267-WRA020-5940) for total of \$1,500,000 (4/5th vote required)

WHEREAS, as a result of a review by the Auditor-Controller's Office in Fiscal Year 2016-17 of the Agency budget, the Auditor-Controller's Office requested the Water Resources Agency to change the way it transfers and allocates special revenues from Zone 2B Fund 119 CSIP Revenue Transfer Fund as prescribed in County Resolution 00-172;

WHEREAS, the request by Auditor-Controller's Office will follow current Generally Accepted Accounting Principles (GAAP); and

WHEREAS, this methodology of transferring the Zone 2B special assessment revenue still follows Resolution 00-172, provides a more transparent method following current GAAP, and stops the co-mingling of the Rate Stabilization Reserve in a Debt Service Fund.

NOW, THEREFORE, BE IT RESOLVED by the Monterey County Water Resources Agency Board of Supervisors that the budget amendment for the Monterey County Water Resources Agency's FY 2016-17 Adopted Budget is approved by:

Agency's annual budget is modified by transferring \$ 3,227,545 from Fund 119 – Water Resources

- Zone #6 special assessment revenue to be allocated as follows: \$843,340 to Fund 131 CSIP Operating Fund, \$549,205 to Fund 132 – SVRP Operating Fund, and \$1,835,000 to Fund 303 - CSIP Debt Service Fund.
- 2. The Rate Stabilization Reserve of \$1,500,000 from Fund 303 Debt Service Fund Unassigned Fund Balance is transferred to Fund 131 CSIP Operating Fund balance.
