WHEREAS, the FAA designated corridor includes selected County offices located on LaGuardia Street, housing certain units for the County's Department of Child Support Services, Department of Social Services (including One-Stop Center) and the Office of Employment and Training, which will need to be closed and cleared of persons on Friday, September 29, 2017 from 3:00 until 5:00 p.m.; and

WHEREAS, the closure of the designated County offices requires Ordinance No. 766, fixing the days and hours of operation of County offices, to be waived for the purposes set forth herein;
