WHEREAS, Monterey County, the cities of Salinas, Gonzales, Soledad, and King, the Monterey County Water Resources Agency, the Castroville Community Services District, and Monterey One Water (formerly the Monterey Regional Water Pollution Control Agency) formed the Salinas Valley Basin Groundwater Sustainability Agency ("Agency"); and

WHEREAS, the Agency is governed by an 11-member Board of Directors, with Directors nominated by specific Members that make appointments to the Board; and

WHEREAS, in March of 2017, the Agency was constituted with an Initial Board of Directors whose terms will expire on September 30, 2017; and

WHEREAS, the County Board of Supervisors is the appointing authority for seven Director positions on the Agency's Board of Directors: 1) one "Other GSA Eligible Entity" position; 2) four "Agricultural" positions representing the Eastside/Langley Sub-basin area, the Forebay Sub-basin area, the Pressure Sub-basin area, and the Upper Valley/Paso Robles Sub-basin area; 3) one "Environment" position; and 4) one "Public Member" position; and

WHEREAS, each Director position will have a Primary and an Alternate Director; and

WHEREAS, the current Initial Directors for the "Other GSA Eligible Entity" Director position have expressed interest in continuing to serve in those capacities; and

WHEREAS, the County has received nominations from the Salinas Basin Agricultural Water Association for the four Agricultural Director positions; and

WHEREAS, the County has received a nomination for the "Environment" Director positions; and

WHEREAS, the Board of Supervisors has considered the nominations, applications, and the qualifications of the individuals presented for consideration as appointees to the Other GSA Eligible Entity, Agricultural, and Environment Director positions; NOW, THEREFORE,

BE IT RESOLVED, by the Board of Supervisors of the County of Monterey as follows:

- 1. The above recitals are true and correct.
- 2. Supervisor Luis Alejo is hereby appointed as the Primary Director to the Other GSA Eligible Entity Director position, and Monterey One Water General Manager Paul Sciuto is appointed the Alternate Director, each for a term of 3 years.
- 3. Colby Pereira is hereby appointed as the Primary Director to the Agricultural Director position representing the Eastside/Langley Sub-basin area, and Kevin Healy is appointed the Alternate Director, each for a term of 2 years.
- 4. Steve McIntyre is hereby appointed as the Primary Director to the Agricultural Director position representing the Forebay Sub-basin area, and Tim Borel is appointed the Alternate Director, each for a term of 3 years.
- 5. Adam Secondo is hereby appointed as the Primary Director to the Agricultural Director position representing the Pressure Sub-basin area, and Dennis Lebow is appointed the Alternate Director, each for a term of 3 years.
- 6. Bill Lipe is hereby appointed as the Primary Director to the Agricultural Director position representing the Upper Valley/Paso Robles Sub-basin area, and William Hinkle is appointed the Alternate Director, each for a term of 2 years.
- 7. Janet Brennan is hereby appointed as the Primary Director to the Environment Director position, for a term of 3 years, and no appointment is made as Alternate Director.
