 periods subject to budget approval;

- Strategies of California withdrew their bid for RFP #10627, and the Committee's recommendation to the Board was changed to recommend award of the contract to Nossaman LLP.
- Recommended that the Board of Supervisors approve a contract in the amount of \$54,000 per year with Nossaman LLP in response to RFP #10628, including the option of renewing the contract for three (3) additional one (1) year periods subject to budget approval.
