- Received a report on the Governor’s Dam Safety proposal, and directed Nossaman to schedule a meeting with WRA and the California Department of Water Resources to explore funding opportunities for WRA;
- Received update on County meeting with the Environmental Justice Coalition for Water (EJCW). EJCW is requesting that the County be the lead applicant on a number of grant applications to provide new water connections for safe, clean drinking water for state small systems and private domestic wells in Monterey County. EJCW is to provide the County with more specific project information and proposed roles and responsibilities for participating parties.
