Voting Rights Act	The Supreme Court struck down Section 4 of the Voting Rights Act in <i>Shelby County v. Holder</i> . Section 4 contains the coverage formula that determines which jurisdictions are subject to the federal preclearance requirement in Section 5. Congress must enact legislation to create a new coverage formula in order for Section 5 to have any effect.
