WHEREAS, to support the reorganization, the Department of Social Services requires the reallocation of three (3) positions: one (1) Accountant I to one (1) Accountant III, one (1) Senior Departmental Information Systems Coordinator to one (1) Business Technology Analyst IV, and one (1) Employment & Training Worker II to one (1) Administrative Services Assistant; and

WHEREAS, the Department of Social Services will require an increase in General Fund Contribution in the amount of \$78,000 for FY 2017-18 in support of the approved transfer of the Office for Employment Training to the Department of Social Services, financed from a reduction
