- 2. Amend Paragraph 17, "Notices", to correct the County's address as follows:

- 3. In all places within the Agreement, any reference to "Exhibit B, Payment Provisions" is hereby replaced with "Exhibit B-1, Payment Provisions" effective November 1, 2015. CONTRACTOR shall be paid based on the Payment Provisions in Exhibit B-1 for work performed after November 1, 2015.
- 4. All other terms and conditions of the Agreement remain unchanged and in full force.
- 5. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
