ON 01/29/2018, THE AGENCY SUBMITTED COMMENTS TO THE RMA-PLANNING DEPARTMENT ON THE ADEIR. THE PURPOSE OF THE COMMENTS WAS TO ADVISE OF THE REGULATIONS AND ENVIRONMENTALS IMPACTS ASSOCIATED WITH FLOOD HAZARDS; THE CONTROL OF FLOOD AND STORM WATERS, AND WATER SUPPLY FOR THE PROJECT. SPECIFICALLY THE COMMENTS TARGETED THE IMPACTS OF BUILDING IN THE FEMA SPECIAL FLOOD HAZARD AREA OF THE CARMEL RIVER INCLUDING A. Impact H-3 Construction and Operation of the Proposed Project would alter the on-site topography and drainage patterns which could result in an increase of on- and off-site runoff and result in the need for flood and storm water control improvements, AND B. Impact H-4 Construction and Operation of the Proposed Project would place commercial retail structures within a 100-year flood hazard area.
