The County Administrative Officer is hereby authorized and directed to take such other and further actions as may be necessary or appropriate to implement the intent and purposes of the Revised Amended and Restated MOU and Master Lease should both be fully executed by the respective parties, including approval of a sub-lease between the City and the Authority upon certification by County Counsel that the terms of the sub-lease are consistent with those of the Revised Amended and Restated MOU and the Master Lease.
