AMENDMENT NO. 1 TO SERVICES AGREEMENT BETWEEN GE HEALTHCARE AND NATIVIDAD MEDICAL CENTER FOR

Maintenance and Repair of Diagnostic Imaging Equipment

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on September 1, 2011 is entered into by and between the County of Monterey (hereinafter "County"), on behalf of Natividad Medical Center (hereinafter "NMC"), and GE Healthcare (hereinafter "GE"); (collectively, the County, NMC and GE are referred to as the "Parties"), with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for GE to provide maintenance and repair services of diagnostic imaging equipment at NMC with a term 09-01-11 through 08-31-18 and a total Agreement amount not to exceed \$3,739,975;

WHEREAS, for invoices from GE for services performed and invoiced under the Agreement dating back to July 1, 2017 and up until February 28, 2018, NMC has compiled past dues in an amount up to \$338,579; and

WHEREAS, NMC and GE currently wish to amend the Agreement by (a) increasing the total Agreement amount by \$1,146,191 to a revised total of \$4,886,166 in order to provide funding for NMC to pay its past dues and to provide adequate funding to cover the costs of the Agreement moving forward, (b) extending the Agreement for an additional one (1) year period through August 31, 2019, and (c) updating the inventory under the Agreement as provided herein.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby amended as follows:

- The term of the Agreement is extended through and including August 31, 2019 for a revised full term of September 1, 2011 through August 31, 2019.
- 2. As of January 1, 2018, the terms and conditions of that certain Service Contract Addendum with Quote ID 9E784ED (the "Service Contract Addendum", attached hereto as <u>Exhibit A</u>) are adopted and incorporated into the Agreement. For the avoidance of doubt, the parties agree that, by signing this Amendment, they are executing, and do not need to separately sign, the Service Contract Addendum.
- The total Agreement amount shall increase by \$1,146,191 for a revised total Agreement amount of \$4,886,166.
 The \$1,146,191 is comprised of the following:
 - Up to \$338,579 shall be applied to outstanding invoices for services provided under the Agreement during the period of July 1, 2017 through February 28, 2018.
 - b. Effective on March 1, 2018, the parties agree that the "Monthly Normal Fixed Charges" shall be \$36,534 per month, for an amount not to exceed \$657,612 through the term of the Agreement (based on the Updated Inventory List attached hereto as Exhibit B, which takes into account the modifications provided for in the Service Contract Addendum). Should the inventory covered by this Agreement later change, the Monthly Normal Fixed Charges shall be increased or decreased accordingly.
 - c. Effective on March 1, 2018, \$150,000 will be allotted by NMC for the remainder of the Agreement term to account for maintenance and repair work as needed for items off inventory (aka; billables) billed at Time & Materials (T&M).

- 4. Within thirty (30) days of any and all inventory changes to the diagnostic equipment inventoried and serviced by GE (ie; additional equipment to be added to the inventory as well as equipment retiring from inventory), the parties will modify the inventory list and the associated Monthly Normal Fixed Charges will adjust accordingly.
- Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 6. This Amendment No. 1 shall be effective when signed by both parties ("Effective Date").
