## Attachment B

This document contains excerpts from the proposed replacement Title 12 to show the substantive changes to the existing Title 12. These changes include the following:

- Addition of Section 12.04.005 defining references to Director of Transportation to mean either the Director as defined in Section 2.28.040 or their designee.
- Modification of Section 12.12.010 to establish a 45 miles per hour speed limit on Carmel Valley Road from State Highway 1 to a point 700 feet west of Phelps way. This change merged 7 sections into one.
- Modification of Section 12.17 to add left turn restrictions Atherton Drive and Mesa Drive onto State Highway 1.
- Modification of Section 12.24.020 in response to community requests and subsequent analysis by RMA staff to add 32 new locations in various parts of the County where 18 are 2-way stops and 14 are all-way stops.
- Modification of Section 12.24.030 Removal of 4 locations with yield signs that were converted to 2-way stops (included in the 18 mentioned above for Section 12.24.020)
- Addition of new section 12.28.005 that delegates authority to the Director of Transportation to establish or remove no parking zones, with appropriate signage or curb markings, at four types of locations: within 100 feet of an intersection, within 20 feet of a driveway, within 25 feet of a railroad crossing and within 15 feet of a fire hydrant
- Modification of section 12.28.010 to add no parking restrictions on Sonoma Lane and Christensen Road.

The changes are shown in strikethrough and underline.

# 12.04.005 DIRECTOR OF TRANSPORTATION.

Director of Transportation as used in this Title means the County Director of Transportation as defined in Sections 2.27.030 and 2.28.040 of Title 2 of the Monterey County Code or their designee.

# 12.12.010 DESIGNATED.

The Board of Supervisors of the County of Monterey having determined upon the basis of an engineering and traffic survey that the vehicle speed limit of 65 miles per hour is more than is reasonable or safe upon those highways, or portions of highways, described in this section, determines and declares the prima facie vehicle speed limits designated in this section for each of said described highways, or portions of highways, which speed limits it finds most appropriate to facilitate the orderly movement of traffic and to be reasonable and safe, and the Director of Transportation of the County of Monterey is directed to erect and maintain appropriate speed restriction signs, as specified by the California Vehicle Code, at the outside entrances of the restricted speed zones described in this section:

Abbott Street, for its entire length, 55 miles per hour;

Arroyo Seco Road, from a point thereon two-tenths of a mile southerly from the existing location of the resort known as Millers Lodge, northerly to a point thereon two-tenths of a mile

northerly from said resort, 35 miles per hour;

**Arroyo Seco Road,** from a point thereon one mile north of the existing location of the resort known as Arroyo Center, south for a distance of eight-tenths of a mile, 35 miles per hour;

**Arroyo Seco Road,** from a point thereon two-tenths of a mile north of the existing location of the resort known as Arroyo Center, south to Monterey County Bridge No. 326 on said highway, 25 miles per hour;

**Avenida Principal,** in the Corral de Tierra Oaks Subdivision, for the limits of the County portion from its eastern intersection with Corral de Tierra Road generally west 2750 feet to its intersection with Paseo Barranco, 35 miles per hour;

Berta Canyon Road, in its entire length, 35 miles per hour;

**Blackie Road,** in Castroville, from its intersection with State Highway 183 generally east to a point 500 feet east of the centerline of its most eastern intersection with Commercial Parkway, 40 miles per hour;

**Blackie Road,** in Castroville, from its intersection with State Highway 183 generally east to a point 500 feet east of the centerline of its most eastern intersection with Commercial Parkway, 40 miles per hour;

**Blackie Road,** from a point 700 feet west of the centerline of Molly Road, easterly to its intersection with State Highway 101, 45 miles per hour;

**Blanco Road,** from a point 1200 feet west of the centerline of Davis Road, easterly to the city limits of the City of Salinas, 50 miles per hour;

**Boronda Road,** from its intersection with Madison Lane generally north to Brooks Road, 35 miles per hour;

**Bradley Road,** in Bradley, from a point 500 feet west of the centerline of Hall Street generally east to a point 500 feet east of the centerline of Sargents Road, 40 miles per hour;

**Cabrillo Street,** from its intersection with Serra Avenue, generally south to its intersection with Pico Avenue, 25 miles per hour;

**Calle del Adobe,** from the city limits of the City of Salinas, westerly to a point 500 feet west of the centerline of Post Drive, 35 miles per hour;

**Calle del Adobe,** from Boronda Road, easterly to a point 500 feet west of Post Drive, 45 miles per hour;

**Canada Drive,** from a point three-tenths of a mile northeast of Rio Vista Drive generally northeast to its intersection with Outlook Drive, 25 miles per hour;

Carmel Rancho Boulevard, for its entire length, 35 miles per hour;

**\_\_\_\_Carmel Valley Road,** from its intersection with State Highway 1 easterly to a point <u>700 feet west of its intersection with Phelps Wayto a point 300 feet west of its intersection with Rio Vista Drive</u>, 45 miles per hour;

**— Carmel Valley Road,** from a point 300 feet west of its intersection with Rio Vista Drive easterly to a point 300 feet east of its intersection with Via Petra, 55 miles per hour;

**Carmel Valley Road,** from a point 300 feet east of its intersection with Via Petra, easterly to a point 2100 feet west of Schulte Road, 50 miles per hour;

**Carmel Valley Road**, from a point 2100 feet west of its intersection with Schulte Road, easterly to a point 1500 feet east of Schulte Road, 45 miles per hour;

**Carmel Valley Road,** from a point 1500 feet east of Schulte Road, easterly to a point 500 feet west of Tierra Grande Drive, 50 miles per hour;

Carmel Valley Road, from a point 500 feet west of Tierra Grande Drive, easterly to a

point 250 feet west of Eddy Road, a private road, 45 miles per hour;

**Carmel Valley Road,** from a point 250 feet west of Eddy Road, a private road, easterly to a point 3000 feet west of the centerline of Laureles Grade, 55 miles per hour;

**Carmel Valley Road,** from a point 3000 feet west of its intersection with Laureles Grade, generally east to a point 700 feet west of its intersection with Phelps Way, 45 miles per hour;

**Carmel Valley Road,** from a point 700 feet west of its intersection with Phelps Way generally easterly to a point 300 feet west of its intersection with Pilot Road, 40 miles per hour;

**Carmel Valley Road,** from a point 300 feet west of its intersection with Pilot Road generally east to a point 150 feet east of its intersection with Esquiline Road, 25 miles per hour;

**Carmel Valley Road,** from a point 150 feet east of its intersection with Esquiline Road generally east to a point 200 feet east of its intersection with Valle Vista, 35 miles per hour;

**Carpenter Street,** from its intersection with State Highway 1, generally southwest to the city limits of Carmel-by-the-Sea, 30 miles per hour;

**Carpenter Street,** from its intersection with State Highway 1, generally northeast to its intersection with Via Mar Monte, 30 miles per hour;

**Carpenteria Road,** in Aromas, from a point 300 feet north of Seely Avenue northerly for a distance of 1800 feet, more or less, to the southerly boundary of the existing 25 mile per hour speed zone located approximately 100 feet south of Carr Street, 35 miles per hour;

**Castro Court,** from its intersection with Castro Road generally west to its terminus, 25 miles per hour;

**Castro Road,** from its intersection with Sylvan Road generally northwest to the city limits of the city of Monterey, 25 miles per hour;

**Castro Way,** from its intersection with Aguajito Road generally east to its intersection with another Castro Road, 25 miles per hour;

**Cattlemen Road,** near San Lucas, from a point 1750 feet generally northwest of its intersection with Lockwood-San Lucas Road generally east to a point 870 feet generally southeast of said intersection, 45 miles per hour;

**Cattlemen Road,** near San Ardo, from a point 825 feet generally north of its intersection with Railroad Street to a point 175 feet generally southwest of its intersection with Rico Street, 40 miles per hour;

**Charter Oak Boulevard,** in the Oak Hills Subdivision, from its more eastern intersection with Oak Hills Drive generally west to its terminus with Cockle Bur Court, 30 miles per hour;

Country Meadows Road, for its entire length, 25 miles per hour;

**Portola Drive,** in the Toro area, from its intersection with Reservation Road generally south to its terminus, 35 miles per hour;

Prunedale North Road, for its entire length, 40 miles per hour;

**Prunedale South Road,** from the existing 25 m.p.h. speed zone 1270 feet north of Blackie Road, northerly to its intersection with Prunedale North Road, 40 miles per hour;

## 12.17 LEFT TURN PROHIBITED.

No person shall make a left turn with a vehicle at any of the following intersections:

## 12.24.020 STOP INTERSECTIONS DESIGNATED.

Intersection of **Avenida Principal and Paseo Terrano (northern intersection),** stops required on Paseo Terrano at both entrances to Avenida Principal;

Intersection of **Avenida Principal and Paseo Terrano (southern intersection),** stops required on Paseo Terrano at both entrances to Avenida Principal;

Intersection of **Axtell Street and Poole Street**, stops required on Axtell Street at both entrances to Poole Street;

Intersection of **Bay View Avenue and Scenic Road**, stop required at the entrance from Bay View Avenue;

Intersection of **Bishop Street and Brooklyn Street**, in **Pajaro**, stop required on Brooklyn Street at the entrance to Bishop Street;

Intersection of **Bishop Street and Florence Street**, in **Pajaro**, stop required on Bishop Street at the northeast entrance to Florence Street (Ord 5279, 11/15/2016).

Intersection of **Blevins Way and Axtell Street in Castroville,** stop required on Axtell Street at the entrance to Blevins Way;

Intersection of **Boronda Road and Brooks Road (a private road),** stop required on Boronda Road at the eastbound entrance to the intersection;

Intersection of **Bradley Road and Bradley Road spur near Camp Roberts**, sign to be maintained stopping westbound Bradley Road spur traffic at north/southbound Bradley Road;

Intersection of **Calle del Adobe and Post Drive**, stops required on Calle del Adobe, except for right turn from Calle del Adobe to Post Drive;

Intersection of **Calle De Los Ositos, Punta Del Monte, Calle De Quien Sabe, and Piedras Blancas,** stops required at both entrances to Calle De Los Ositos and Punta Del Monte from Calle De Quien Sabe and Piedras Blancas;

Intersection of **Camino del Monte and Guadalupe Street**, stops required at both entrances to Camino del Monte from Guadalupe Street;

Intersection of **northbound Camino del Monte, westbound Camino del Monte, Pescadero Road, and San Marcos Road,** stops required on westbound Camino del Monte and Pescadero Road;

Intersection of **Camino Real and Fifteenth Avenue, near the City of Carmel-by-the-Sea**, stops required at both entrances from Fifteenth Avenue;

Intersection of **Carmel Hills Drive and Ocean Avenue near Carmel, s**top required on Carmel Hills Drive in the southbound direction at the entrance to Ocean Avenue;

Intersection of **Carmel Hills Drive and Stewart Place**, stop required on Stewart Place at the entrance to Carmel Hills Drive;

Intersection of **Carpenteria Road and Blohm Avenue**, in Aromas; stops required at all three entrances to the intersection;

Intersection of **Carpenter Street**, **Via Mar Monte and High Meadows Drive**, in the Carmel area; stops required at both entrances to Carpenter Street and its prolongation into High Meadow Drive from Via Mar Monte;

Intersection of **Cayetano Street and Florence Street**, in **Pajaro**, stop required on Cayetano Street at the southwest entrance to Florence Street (Ord 5279, 11/15/2016);

Intersection of **Center Street and Martin Street in San Ardo,** stop required on Center Street in the southbound direction at the entrance to Martin Street;

Intersection of **Center Street and Godchaux Street in San Ardo,** stops required at all four entrances;

Intersection of **Charter Oak Boulevard and Cathedral Oak Road**, stops required on Charter Oak Boulevard at both entrances to Cathedral Oak Road;

Intersection of **Charter Oak Boulevard and Oak Hills Drive**, stops required at all four approach legs of the intersection;

Intersection of **Clay Street and Washington Street**, stops required at both entrances to Clay Street from Washington Street;

Intersection of **College Street and Jolon Street in San Ardo**, stops required at all three entrances to the intersection;

Intersection of **Cooper Street and Blevins Way in Castroville,** stop required on Blevins Way at the entrance to Cooper Street;

Intersection of **Cooper Street and Seymour Street**, stops required at all four entrances to the intersection;

Intersection of **Cornwall Street and Kelton Drive**, stop required on Cornwall Street at the intersection with Kelton Drive;

Intersection of **Corral de Tierra Road**, **Robley Road and Calera Canyon Road**, stops are required at all four entrances to the intersection;

Intersection of **Country Meadows Road and Meadow Ridge Road,** stop required on Meadow Ridge Road at the entrance to Country Meadows Road;

Intersection of **Country Meadows Road and Reese Circle**, stop required on Country Meadows Road at the entrance to Reese Circle;

Intersection of **Crane Street and Seymour Street**, stops required on Crane Street at both entrances to Seymour Street;

Intersection of **Cross Road and Lockwood Jolon Road**, stops required at both entrances to Lockwood Jolon Road from Cross Road;

Intersection of **Cross Road and Reese Circle in Prunedale**, stop required on Cross Road at the entrance to Reese Circle;

Intersection of **Davis Street and Rico Street**, stops required on Davis Street at both entrances to Rico Street;

Intersection of **Denner Road and Paul Avenue**, stop required on Denner Road at the intersection with Paul Avenue;

Intersection of **Doud Road and Doud Road Spur**, sign to be maintained stopping southbound Doud Road spur traffic;

Intersection **El Camino Real and Susan Lane**, to be maintained stopping eastbound Susan Lane traffic;

Intersection of **Fern Canyon Road and Highlands Drive**, stop required at the entrance to Highlands Drive from Fern Canyon Road;

Intersection of **Fifth Street and Llano Avenue, in Spreckels, s**top required on Llano Avenue at the entrance to Fifth Street;

Intersection of **Fifteenth Avenue and Dolores Street**, stop required at the entrance from Fifteenth Avenue;

Intersection of **Fifteenth Avenue and Monte Verde Street**, stops required at all four entrances to the intersection;

#### **12.28.005 PROHIBITED – SPECIFIED PLACES.**

(a) The Director of Transportations is hereby authorized to prohibit stopping, standing or parking and directed to place and maintain appropriate signs and curb markings giving notice of this regulation at any of the following places when such prohibition as indicated by a traffic engineering investigation will alleviate dangerous hazardous traffic conditions or facilitate the full use of the roadway:

(1) At any place within 100 feet of the intersection of two or more highways;

(2) At any place within 25 feet of a railroad grade crossing;

- (3) Adjacent to either side of a crosswalk or driveway entrance for a distance not to exceed 20 feet from either side of such crosswalk or driveway;
- (4) Adjacent to any fire hydrant for a distance not to exceed 15 feet on either side when it

has been determined that stopping, standing or parking of any vehicle, whether attended or unattended, would present some special hazard or would prevent ready access to the fire hydrant.

(b) When the Director of Transportation, upon the basis of a traffic engineering investigation, finds that the conditions no longer exist to prohibit stopping, standing or parking as authorized in 12.28.005 (a), the Director shall remove such signs and such curb markings from such portion of such street or highway.

## 12.28.010 PROHIBITED - AT ALL TIMES.

No person shall stop, park, or leave standing any vehicle, whether attended or unattended, except when necessary to avoid conflict with other traffic or in compliance with the directions of a peace officer or official traffic-control device, in any of the following places at any time, and the Director of Transportation of the County of Monterey is directed to place and maintain appropriate signs or curb markings giving notice of this regulation at such places:

**Crosswalks.** On the right-hand side of any road or street, within 100 feet of the approach side of any yellow marked crosswalk, or within 50 feet of the departure side of such a crosswalk; and on the right-hand side of any road or street, within such number of feet of the approach side of any white-painted crosswalk as equals the sum of the speed limit in miles per hour for such road or street at such crosswalk, plus 10 feet.

**117 Drive.** Along the west side of 117 Drive from the north end (including the cul-de-sac in its entirety) southerly for 1400 feet;

Addington Road, on both sides of Addington Road between Calle Del Adobe and Fontes Lane;

Anza Drive, on the north side of Anza Drive, in Serra Village, from a point 240 feet west of the centerline of Anza Circle, westerly for a distance of 25 feet;

**Arroyo Seco Road,** on both sides of Arroyo Seco Road from a point 1025 feet east of Monterey County Bridge number 326, easterly for a distance of 8000 feet.
