Use Permit to allow the construction of four wells and allow the temporary exploration for and removal of oil and gas at the following locations: Hames Valley Exploration Well #1: 5,000 feet west of Nacimiento Lake Drive, 1 mile south of Jolon Road (Assessor's Parcel Number 424-081-046-000). Hames Valley Exploration Well #2: 1,200 feet east of Nacimiento Lake Drive, (Assessor's Parcel Number 424-081-050-000). Hames Valley Exploration Well #3: 2 miles south of Jolon Road and 1 mile east of Nacimiento Lake Drive (Assessor's Parcel Number 424-111-001-000). Hames Valley Exploration Well #4: 1 mile south of Jolon Road and ¼ mile west of Nacimiento Lake Drive, Bradley (Assessor's Parcel Number 424-081-083-000), South County Area Plan.

Steve Rawley, Stan Esner and Bob Beuer all representing Trio Petroleum made a presentation to all persons in attendance at the meeting. They described in detail the parameters of the 4 exploratory well drilling sites and explained the benefits of their research in locating the drilling sites. All four sites are located within the lands owned by the same family and all private roadways are within the same family ownership. They stated that each drill site is independent of each other. One site will be explored at a time; with each site having a footprint of approximately 1 to 1 ½ acres. The method of "directional" drilling to allow for a minimal ground disturbance (project footprint) was also explained. The representatives of Trio Petroleum described the nature of the oil they are hoping to find as having higher gravities that will come up out of the ground by the naturally occurring geologic pressures surrounding the drill sites. No heat, steam or chemical process will be used to extract the oil.
