WHEREAS, **Alan McKay** served as the Chief Executive Officer (CEO) of the Central California Alliance for Health for nearly 23 years, starting with the health plan's inception in Santa Cruz County in April 1995 through his retirement in February 2018; and

WHEREAS, **Alan McKay** was hired as a consultant in 1993 to develop a Medi-Cal managed care plan for Santa Cruz County using the State County Organized Health System (COHS) model; and

WHEREAS, **Alan McKay** guided the Alliance through multiple expansions, growing the health plan from 25,000 members in Santa Cruz County in 1996 to 350,000 members combined in Santa Cruz, Monterey and Merced Counties today, receiving multiple awards from the State of California along the way in the areas of health care quality and customer service delivery; and

WHEREAS, **Alan McKay** served as a member of the Merced County Health Care Consortium, the Monterey Regional Health Development Group, Inc. (MoReHealth), and the Health Improvement Partnership of Santa Cruz County; and

WHEREAS, Under **Alan McKay's** leadership the Alliance received recognition as a high ranking and multi-award winning organization for outstanding health plan performance, quality and leadership in health care, including a Quality Award from the Department of Health Care Services for outstanding performance for 2015 Healthcare Effectiveness Data Information Set (HEDIS®) measures for Medi-Cal managed care; and

WHEREAS, Since the Alliance was established in 1996, it has saved taxpayers more than \$414M compared to the State's Medi-Cal program through local services and provider incentives that promote prevention and cost-effective care; and

WHEREAS, **Alan McKay** holds a Master of Public Health degree from University of California at Berkeley, and a Bachelor of Arts degree in Psychology from the University of California at Santa Cruz; and

WHEREAS, **Alan McKay** was born in Long Island, New York and grew up in Montana and Santa Barbara, ultimately settling along the Central California coast in Santa Cruz with his wife Maggie. Together they have two children, daughter Carolee who is married to Ryan Trimmerger, and son Nick who is married to Caroline Healy-McKay, and one grandchild with who they are looking forward to spending more time. Alan is an avid motorcyclist, and he also enjoys running and bicycling in the Santa Cruz area;
