Attached is the letter which I sent Chairman Keith Vandevere in December regarding the Bailey item which is scheduled to be heard tomorrow. At December's hearing, we explained that there was no need to prepare an initial study and negative declaration and that the application should qualify for a categorical exemption as the staff had initially recommended. Apparently in response to comments by Commissioners regarding the lack of findings to support the categorical exemption at the October hearing, the staff felt the Commission would not support the use of a categorical exemption.

Unfortunately in the intervening months, the staff has been unable to prepare and circulate the initial study and negative declaration. It is equally unfortunate that so much time has elapsed that the time maximum time allowed by state law for the county to process this application (six months from the date the application is deemed

complete) expires on March 13.

I am reiter	ating my request from December that the application be considered based on a categorical	al exemption. At
least that w	yould allow this county to conduct a hearing on March 14 and only exceed the maximum t	ime allowed by law
