NOTICE IS HEREBY GIVEN that pursuant to Section 6066 of the Government Code of the State of California and Monterey County Water Resources Agency Ordinance No. 2626, the Board of Supervisors of the Monterey County Water Resources Agency on behalf of Zone 9 has elected to collect benefit assessments to cover costs not otherwise offset by other revenue for the Fiscal Year 2018-19 on the tax roll in the same manner as general taxes, and has caused to be filed with its Clerk a written report containing a description of each parcel of real property in Zone 9, and the amount of such benefit assessment on each property for Fiscal Year 2018-19 for each such parcel.
