# AMENDMENT NO. 2 TO SERVICES AGREEMENT BETWEEN HEALTH CARE INTERPRETER NETWORK AND NATIVIDAD MEDICAL CENTER FOR SHARED INTERPRETER SERVICES

This Amendment No. 2 to the Services Agreement ("Agreement") which was effective on July 1, 2015 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and Health Care Interpreter Network (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

## RECITALS

WHEREAS, the Agreement was executed for Shared Interpreter Services with a term July 1, 2015 through June 30, 2018 and a total Agreement amount not to exceed \$195,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement May 10, 2017 via Amendment No. 1 to revise the original scope of work to include video units for live streaming with no change to the original agreement amount; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional three (3) year period through June 30, 2021 to allow for services to continue with revisions to the equipment fees attached hereto as "Exhibit A-2 per Amendment No. 2" with a \$195,000 increase for a total Agreement amount of \$390,000.

### **AGREEMENT**

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and in Amendment No. 1 incorporated herein by this reference, except as specifically set forth below.

- 1. Section 2 titled, "PAYMENTS BY NMC", last sentence shall be amended to the following: "The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$390,000."
- 2. The first sentence of <u>Section 3 titled</u>, "TERM OF AGREEMENT" shall be amended to the following: "The term of this Agreement is from July 1, 2015 through June 30, 2021 unless sooner terminated pursuant to the terms of this Agreement."
- 3. Section 4 titled, "ADDITIONAL PROVISIONS/EXHIBITS" shall be amended to the following: "The following attached exhibits are incorporated herein by reference and constitute a part of this Agreement:

4. Except as provided herein, all remaining terms, conditions and provisions of the Original Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement and in Amendment No.1.

#### A. SERVICE AND DELIVERABLES

## A.1 CONTRACTOR Obligations:

- a. CONTRACTOR shall be responsible for maintaining the system's IT platform, confirming that the interpreters that are shared on the network meet the qualifications as required by the HCIN Program Committee.
- CONTRACTOR shall be responsible for maintain 24/7 engineering system support to the network.
- c. CONTRACTOR shall configure the Call Center to incorporate access for NMC. CONTRACTOR shall also provide NMC Interpreter Services Director a monthly report summarizing the previous month's activity which will include a detailed list of all the calls routed through HCIN for NMC.
- d. CONTRACTOR shall provide automated routing of video and telephone interpretation requests from NMC staff and physicians to NMC interpreters and HCIN.
- e. CONTRACTOR shall provide the same video streaming on the ipad as provided on the Cisco Video Phone and at the same cost. Interpreter video streaming shall be available on ipad during same hours of operation as the Cisco Video Phone units.
