AMENDMENT No. 5 TO SERVICES AGREEMENT BETWEEN Nixon Peabody LLP AND NATIVIDAD MEDICAL CENTER FOR Legal Services

This Amendment No. 5 to the Services Agreement ("Agreement"), dated October 10, 2011 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and Nixon Peabody LLP., (hereinafter "CONTRACTOR"), with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for Legal Services with a one year term October 10, 2011 through June 30, 2012 and a total Agreement amount not to exceed \$100,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on March 1, 2011 Amendment No. 1 to extend the term for an additional one (1) year period through June 30, 2013, increasing the scope of services and adding an additional \$200,000, for additional services thereby increasing the total Agreement amount to \$300,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on July 1, 2013 via Renewal and Amendment No. 2 to extend the term for an additional one (1) year period through June 30, 2014; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on July 1, 2014 via Amendment No. 3 to extend the term for an additional three (3) year period through June 30, 2017; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on May 16, 2017 via Amendment No. 4 to extend the term for an additional one (1) year period through June 30, 2018; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement effective July 1, 2018 via Amendment No. 5 to extend it for an additional three (3) year period through June 30, 2021 with no increase to the total agreement cost.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in Original Agreement and in Renewal and Amendment No. 1, Renewal and Amendment No. 2, Amendment No. 3, Amendment No. 4 incorporated herein by this reference, except as specifically set forth below.

- 2. The first sentence of Section 3 "TERM OF AGREEMENT" shall be amended to the following; "The term of this Agreement is October 10, 2011 to June 30, 2021 unless sooner terminated pursuant to this Agreement"
- 3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 5, and shall continue in full force and effect as set forth in the Amendment No. 4, Amendment No. 3, Renewal and Amendment No. 2 Amendment No. 1, and Original Agreement.
- 4. A copy of this Amendment No. 5 shall be attached to the Original Agreement.
