Resolution Commending **Michael R. Shapiro** upon his retirement)
after 29.5 years of service with the Monterey County Sheriff's Office.....)

WHEREAS, Deputy Michael Shapiro was born in Los Angeles, California and raised in Los Angeles and Florida, before his family settled in Monterey, California in 1972; and

WHEREAS, Deputy Michael Shapiro graduated from Carmel High School, attended Monterey Peninsula College and later attended the San Jose Evergreen Valley College Police Academy where he was placed on the Dean's list for obtaining a 4.0 GPA; and

WHEREAS, Deputy Michael Shapiro was hired by the Monterey County Sheriff's Office after being self-employed/owner of four service stations and an automotive towing company; and

WHEREAS, Deputy Michael Shapiro was sworn in on June 1, 1987 by Sheriff Cook and over his career served for six Monterey County Sheriffs: D.B "Bud" Cook, Norman Hicks, Gordon Sonn , Mike Kanalakis, Scott Miller and Steve Bernal; and

WHEREAS, Deputy Michael Shapiro was a member of the Sheriff's Office Motor Squad for 13 years, participated in the juvenile impact gang diversion program and served briefly as a Civil Deputy; and

WHEREAS, Deputy Michael Shapiro served nearly all his career as an Enforcement Operations Deputy working on patrol at the Central and Coastal Patrol Stations and retires as an Enforcement Operations Deputy assigned to the Coastal Patrol Station; and

WHEREAS, Deputy Michael Shapiro has been recognized on many occasions for his accomplishments while working as a patrol deputy in the Enforcement Operations Bureau and in 1991 was awarded Deputy of the Year for his stellar performance throughout the year; and

WHEREAS, Deputy Michael Shapiro received an Outstanding Service Award in August 1996, for his proactive efforts in a narcotics arrest resulting in the seizure of approximately seven pounds of cocaine during one contact, and approximately 20 separate arrests throughout the year related to illegal drug activity and on April 1, 1998, Deputy Shapiro received an Outstanding Service Award and an Award of Merit for his initial investigation into a report of a ransacked residence and a missing 11-year-old child where his investigation lead to the arrest of a homicide suspect; and

WHEREAS, Deputy Michael Shapiro received the Sheriff's Meritorious Service Award and Certificates of Recognition from the California State Senate and U.S. Congress on January 23, 2008, for his expertise in the field of fraud and financial crime investigations. In 2007, Deputy Shapiro investigated and solved numerous cases related to fraud and financial crimes where his efforts greatly exceeded those normally associated with a patrol deputy, and his investigation emulated that of an accomplished detective; and

WHEREAS, Deputy Michael Shapiro, over his career received numerous other commendations and recognition, to include many letters of appreciation from citizens, staff, community organizations, and law enforcement agencies, who have praised **Deputy Michael Shapiro** for his exceptional work, team work, and community commitment.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Monterey on behalf of all people thereof, acknowledges, commends, and thanks **Deputy Michael Shapiro**, for his 29.5 years of exemplary public service to the People of Monterey County as a valued member of the Monterey County Sheriff's Office.
