Good day to you. For those of you who I have not met, my name is Cam Sanchez with Monterey County RMA, and I currently serve as the Interim Chief of Parks. I wanted to introduce myself, and follow up on the Parks Commission presentation and next steps. I realize that you have not heard from us in quite some time, and this is on us, and I want to sincerely apologize.

On April 5, 2018 Parks Staff provided an update to the Parks Commission regarding Toro Trails. It was a brief presentation regarding where we currently are with this matter and what we want to move forward with in addressing the trails issues and concerns and some next steps. One of those next steps is to present at the May Parks Commission meeting more of the in- depth vision for the Toro Trails and what we want to accomplish for the long haul.


