WHEREAS, the COUNTY and CONTRACTOR wish to acknowledge and incorporate the terms and conditions of the Judicial Council of California MA-201307 Amendment No. 3, dated October 23, 2017, attached hereto as Attachment A into the **Participating Agreement** whereby the term has been extended for one additional year, through December 31, 2018.

**WHEREAS**, the parties desire to amend that Participating Agreement to reflect the County's exercise of the option to extend the term, on the same or similar terms, for the period of May 1, 2018 through December 31, 2018.

**NOW THEREFORE**, the County and CONTRACTOR hereby agree as follows:

- 1. The **PARTICIPATING AGREEMENT** between COUNTY and CONTRACTOR is hereby amended and extended to include the period of May 1, 2018 through December 31, 2018, unless sooner terminated pursuant to the terms of the **PARTICIPATING AGREEMENT** or extended in writing by parties.
- 2. The terms and conditions of the Judicial Council of California MA-201307 Amendment No. 3, dated October 23, 2017, attached hereto as Attachment A into the PARTICIPATING AGREEMENT.
