DEPARTMENT UPDATE

Staff to start tracking for performance measures; volunteer hours, live on or not, park reservations, and project logs for Buildings & Grounds. Rangers are now tracking citations, case reports and daily logs and turning them in daily.

Beginning June, they will assess the big projects that need to be done at the various Parks and move staff around to get those projects done.

Ranger Madison Johnson will be retiring in June.

Volunteers and Building and Grounds staff will be doing more management of the Parks, such as closing, so the Rangers can do more enforcement.

The Avenue of Honor at San Lorenzo Park, depicts names of service folks from the County who served in WW1 to the current war. The display is made from wood and falling apart. The project has been given to go ahead to be updated. The VFW and the Young Farmers of King City have already raised half the money. We will ask the Parks Foundation to request the rest of the funds needed to complete the project.
