#### **PUBLIC COMMENT**

ACTION: There was no comment from members of the public.

#### COMMISSIONER COMMENTS, REQUESTS, REFERRALS

- Commissioner Hughett reminded commissioners about the Monterey Bay National Marine Sanctuary recreation fishing online newsletter and encouraged commissioners to read it over, and provide suggestions/input if they are willing.
- Commissioner Brockman suggested, in the future, we limit or grant funding to Monterey County organizations/personnel only or cap funding at \$1,500.
- Commissioner Kreyenhagen expressed his disappointment in the lack of funding provided by the Santa Cruz F&G Commission and suggested we reach out to encourage them to support those applicants with projects in their county.
- Commissioner DeHart stated he participated in a recent local hunter's education course with 20–25 children in attendance.
- Commissioner Hughett announced he would be travelling to Loreto, Mexico for a fishing trip and other commissioners are welcome to sign up if interested.
- Commissioner Sargenti asked what the appropriate course of action is when local ranchers come to him as a commissioner with complaints. Commissioner Urquhart clarified that bringing the issue to the commission meetings is appropriate since the issue can be discussed with DFW personnel who are our local fish and wildlife representatives for the county.

#### SCHEDULED MATTERS

#### 1. Receive a verbal report from the California Department of Fish & Wildlife

Lt. Schindler is trying to look into the issue concerning missing/lacking fine monies but the person responsible within their department is currently out on medical leave. Commissioner Kreyenhagen asked if any fines would be imposed on those responsible for the diesel fuel within the harbor. Commissioner Urquhart responded that those fines are implemented by the Sanctuary. The Office of Spill Prevention and Response responded to the spill, not DFW, and therefore, any fines resulting from a violation would not come to the commission.

#### 2. 2017–2018 Fish and Game Propagation Grand Fund Applicant Presentations

#### a) Marine Life Studies

Submitted and presented by Peggy Stap, Marine Life Studies is seeking funding for the purchase of equipment for their Whale Entanglement Team program. Unfortunately, someone was killed during a disentanglement in 2017, causing NOAA to temporarily shut down entanglement programs while safety measures were reevaluated. NOAA released new safety standards and additional equipment is needed by Marine Life Studies to satisfy the new NOAA safety requirements. Funding request: \$2,949.

#### b) Lazy Arrow Outdoor Adventures

Submitted by Mark Morrison in support form the CA Department of Fish and Wildlife Wardens Hank Hodel and Matt Gil who presented presented the proposal on behalf of the annual Lazy Arrow Outdoor Adventures. The event was started by longtime warden Ray Azbill as an outdoor educational event aimed at teaching local youth from Monterey and San Luis Obispo counties the aspects of hunting. The event is similar to the hunter education course where participants are educated, trained, and participate hands on in an actual (pheasant) hunt. The event now includes a youth and women's hunt. One third of the women participating in the women's hunt were from Monterey County. The Jr. hunt hosted a total of 72 participants over two days. A game bird club license fee of \$400 in addition to other expenses are necessary to hold the event. Funding request: \$2,500.

#### c) Ventana Wildlife Society (VWS)

Submitted by Kelly Sorenson, presented by Mike Stake, VWS coordinates a program that aims to work cooperatively with Monterey County hunters to reduce the amount of lead from spent ammo in the local environment. VWS is not opposed to hunting, as condors rely on carcasses, but is hoping to encourage the

use of non-lead ammo. An online raffle allows hunters to apply for one box of non-lead ammo approved for use within the identified condor range. In 2017, 1500 boxes of ammunition were distributed; 773 boxes to Monterey County residents in total since 2012. Funding will go towards purchase of ammo from cooperating suppliers. Funding request: \$5,000.

#### d) O'Neill Sea Odyssey (OSO)

Submitted and presented by Dan Haifley, OSO is a living classroom on a 65-ft catamaran within the Monterey Bay National Marine Sanctuary founded in 1996. Students from 4–6<sup>th</sup> grades engage in hands-on learning about the marine habitat. The free of charge program teaches math and science skill using ocean concepts, and encourages environmental stewardship of marine wildlife and habitats. In 2016–2017, the Commission granted funds that were used to provide transportation for 4 classes from King City. If awarded, this year's funding request will be applied toward bus transportation of 4 Monterey County classrooms. Funding request: \$2,500.

#### e) Real Good Fish

Submitted and presented by Alan Lovewell, the Bay-2-Tray program is a collaborative education effort between local fishermen, Real Good Fish, Monterey Bay National Marine Sanctuary (MBNMS), and area schools/universities. Bay-2-Tray provides public school lunches with local fish that have no existing market—the Pacific grenadier is a bycatch species that is often discarded. MBNMS sends professional fishermen to local classrooms to educate students on the local fishing culture and what it means to be a commercial fisherman; the catch (Pacific Grenadier) is sold to the district for student lunches. Program curriculum fulfills grade-appropriate learning objectives. The program has been ongoing for 4 years and is finding success as fish tacos outsell pizza in the Monterey Bay Peninsula School District. They are looking to expand their program beyond Monterey. Funding request: \$10,334.45.

#### f) Save Our Shores

Submitted by Katherine O'Dea, presented by Tucker Hirsch, Save Our Shores is an educational program that incorporates alternative marine science presentations with student beach cleanups. The program introduces students to both fresh and marine aquatic ecosystems and highlights human's interactions and interdependence in our region. They would like to modernize their program by purchasing new computers and software for classroom use and tablets for data collection in the field as well as conserving paper by having students and volunteers digitally sign waivers. Funding will go towards laptops, software, tablets, and associated accessories. Funding request: \$12,500.

#### g) Reef Check Foundation

Submitted by Jan Freiwald, Reef Check is an international organization that looks at the health of coral reefs using trained volunteer divers/local fishermen/ecotourist operators. In 2006, a program was developed for California to look at kelp forests. One-quarter to one-third of CA sites are in Monterey County. Transects are mostly done once per year, some twice. Collected data is recorded in the Global Reef Tracker (<a href="www.data.reefcheck.us">www.data.reefcheck.us</a>) where it is available to marine managers to make better decisions based on scientific data. The program is funded by state and private donations. It does identify invasive species, mostly in Southern California. It also is tracking sea-star die off, which is leading to an explosion of urchins as the sea-star is their natural predator. The program is also able to respond to localized events such as spills to track the effects of pollution on the environment. Reef Check was unable to send a representative to present on their behalf. Funding request: \$3,500.

#### h) Rancho Cielo

Submitted and presented by Roy Melendez, Rancho Cielo is a 100-acre educational facility that opened in 2004 and offers 2 fishing ponds, a community garden, a new hop garden and their renown culinary academy. A solar aeration system has been purchased for the lower pond, and now funding is requested for a system to be installed at the upper pond. The previous pump burned out due to constant use, corrosion, and being undersized. Without a sufficient aeration system, algal blooms are problematic and lowering the quality of water for fish as well as decreasing the potential for recreational activities. Funding will be applied

towards the total cost to install a solar aeration system at the lower pond. <u>Funding request: \$10,000.</u>

#### i) Monterey Bay Salmon and Trout Project STEP program

Submitted by Ben Harris, presented by Meg Seibert, the program aims to improve salmon fishing in Monterey Bay by rearing Chinook salmon (Salmon enhancement program). This program coordinates with STEP in raising awareness in K-12 grades of salmonid biology and in protecting and improving salmonid habitat. Currently, 50% of the students participating are from Monterey County. Funding would be applied towards the purchase of supplies and materials necessary to conduct teacher training and equipment for field trips. Funding requested: \$4,000.

#### **SUMMARY**

Prior to the submittal deadline, staff received an application from the Reef Check Foundation requesting funds in the amount of \$3,500 from the Fish & Game Advisory Commission's 2017/18 Propagation Grant Fund program. The Commission considered applications at the February meeting where 12 grant requests were received and 11 awarded totaling \$58,283.45. Representatives of Reef Check Foundation were not able to make the February meeting to present their project and the Commission continued this one application to the April meeting when a representative could come and present on their request.

#### **DISCUSSION:**

The Reef Check Foundation is an international organization that looks at the health of coral reefs using trained volunteer divers/local fishermen/ecotourist operators. In 2006, a program was developed for California to look at kelp forests. One-quarter to one-third of CA sites are in Monterey County. Transects are mostly done once per year, some twice. Collected data is recorded in the Global Reef Tracker (<a href="www.data.reefcheck.us">www.data.reefcheck.us</a>) where it is available to marine managers to make better decisions based on scientific data. The program is also able to respond to localized events such as spills to track the effects of pollution on the environment. If awarded, the funds would be used to educate the public and involved jurisdictions on the value of coral reefs and rocky reef ecosystems and the crisis they face, create a network of volunteer teams, trained and led by scientists, to regularly monitor and report on reef health using a standard method, facilitate collaborative use of reef health information by community groups, governments, universities, and businesses to design and implement ecologically sound and economically sustainable solutions, and stimulate local action to protect remaining pristine reefs and rehabilitate damaged reefs worldwide

Representatives from Reef Check Foundation have confirmed their attendance for the April 10, 2018 F&G Game Commission meeting. Staff recommends that the Commission consider and determine the funding request. Staff will forward the Commission's recommendation(s) to the County Board of Supervisors for their consideration (date TBD) and final approval.

#### **SUMMARY/DISCUSSION:**

In December of 2015 a settlement was reached on behalf of the Monterey County District Attorney's office involving a poaching case that occurred on Fort Hunter Liggett. The DA's office worked with the Department of Fish & Wildlife Game Wardens and the individuals involved to reach an agreed settlement amount of \$50,000. The funds are to be administered by the Monterey County Fish and Game Advisory Commission; there are no obligations or stipulations regarding use of the funds and no other entities are entitled to a share.

The Commission decided to set up a working group to consider ways to use the settlement funds, with the goal of supporting relevant research in the areas fish and wildlife resource education, protection and enhancement. The members of the working group are Commissioners Hughett, Guilliam, Evans, Medley and Monares. The working group proposed a scholarship program (acknowledging F&G Commissioners who had passed on) to be an appropriate use of the settlement funds. After researching the anticipated work related to administering a scholarship program it was determined that there were not the required resources available to administer the scholarship program and the commission expressed an interest in other possibilities for use of the funds.

At the February 13, 2018 Fish & Game Commission meeting, Commissioner Hughett passed out a memo regarding the use of the settlement funds and proposed research projects that might be funded (see attached). It was also decided to use \$20,000 of the \$50,000 settlement to help offset the lack of fine monies in this year's Propagation Grant Fund program. For the remaining \$30,000, Commissioners were asked to provide a list of 5 of their most important projects that the full Commission should consider, and bring the list to the April 2018 meeting for further discussion.

#### **OTHER AGENCY INVOLVEMENT:**

It is anticipated that CAO, County Counsel, Auditors, and RMA Department will possibly be involved.

#### **FINANCING:**

This action has no impact on the General Fund; \$20,000 will be allocated to the Propagation Grant Fund program, leaving \$30,000 in settlement funds.

Report from the committee that includes: Commissioners Evans, Guilliam, Hughett, Medley and Monares.

The above listed commissioners have discussed a proposed research grant program with the intent to use the \$50,000.00 settlement funds that the commission received last year and instead of a grant program, they are recommending that the funds be used in the following manner:

We've agreed that instead of spending the time and money that it would take to develop and operate a separate research grant program, it would be easier, cheaper (no cost) and more effective to use our current grant program and application to make the funds available to prospective researchers. We will continue to function as a committee to the commission and seek out research teams or individuals to gather information for possible projects to be sponsored by the commission. To start this process we will be asking all of our fifteen commissioners to submit a list of the five most important projects they believe we should undertake for the enhancement of our county's wildlife, fish and game.
