SEVENTH AMENDMENT TO PROFESSIONAL SERVICE AGREEMENT

THIS SEVENTH AMENDMENT TO PROFESSIONAL SERVICE AGREEMENT (the "Amendment") is made and entered into as of January 1, 2017, by and between COUNTY OF MONTEREY ("County") on behalf of NATIVIDAD MEDICAL CENTER ("NMC"), and DANNY TAN DDS ("Contractor") with respect to the following:

RECITALS

- A. NMC operates the Natividad Immunology Division Outpatient Clinic, (the "NIDO Clinic"), a comprehensive primary care clinic that provides services, including referrals for dental services, to people over the age of thirteen with HIV/AIDS and other infectious diseases.
- B. Contractor and NMC have entered into that certain Professional Service Agreement dated February 1, 2011, as amended on February 15, 2012; July 1, 2012; July 1, 2013; July 1, 2014; July 1, 2015 and July 1, 2016 (collectively, the "Agreement") pursuant to which Contractor provides comprehensive dental services to patients referred by the NIDO Clinic.
- C. NMC and Contractor desire to amend the Agreement to add \$25,000 to the not to exceed amount.

AGREEMENT

IN CONSIDERATION of the foregoing recitals and the mutual promises and covenants contained herein, NMC and Contractor agree as follows:

- 1. <u>Defined Terms</u>. Capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Agreement.
- 2. <u>Amended Section 1</u>. PAYMENTS BY NMC. Section 1 of the Agreement is hereby deleted and replaced with the following: "NMC shall pay the Contractor in accordance with the payment provisions set forth in Exhibit A, subject to limitations set forth in this Agreement. The total amount payable by NMC to Contractor under this agreement shall not exceed the sum of Three Hundred Seventy Thousand Dollars (\$370,000) in the aggregate."
- 3. <u>Counterparts</u>. This Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
- 4. <u>Continuing Effect of Agreement</u>. Except as herein provided, all of the terms and conditions of the Agreement remain in full force and effect from the Effective Date of the Agreement.
- 5. <u>Reference</u>. After the date of this Amendment, any reference to the Agreement shall mean the Agreement as amended by this Amendment.
