AMENDMENT NO. 1 TO SERVICES AGREEMENT BETWEEN CARDIONET LLC AND NATIVIDAD MEDICAL CENTER FOR HOLTER MONITORING SERVICES

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on July 1, 2014 is entered into by and between the County of Monterey (hereinafter "County"), on behalf of Natividad Medical Center (hereinafter "NMC"), and CardioNet LLC (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

- 1. Paragraph titled "TERM OF AGREEMENT", first sentence shall be amended to the following: "The term of this Agreement is from July 1, 2014 through June 30, 2018 unless sooner terminated pursuant to the terms of this Agreement."
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect.
- 3. A copy of this Amendment No. 1 shall be attached to the Original Agreement.
- 4. This Amendment No. 1 shall be effective when signed by both parties.
