WHEREAS, the Jail Security Improvement project is comprised of phases 1-4 where phase 1-3 included ADA upgrades, suicide prevention, and installation of a new video surveillance system and phase 4 includes a new door locking control system that will be integrated with the newly upgraded camera system; and

WHEREAS, the entire project was anticipated to cost \$7,908,881 financed with Capital Projects Fund 402 fund balance of \$700,000, General Fund unassigned fund balance of \$371,196 and Strategic Reserves transferred to the General Capital Assignment fund balance of \$6,837,685; and

WHEREAS, Phase 1-3 was completed on time at a cost of \$3,479,321 and Phase 4 of the project is estimated to cost \$1,695,702, which will result in total estimated project cost of \$5,175,023; and

WHEREAS, funds made available in Capital Projects Fund 402 for the Jail Security Improvement Project total \$4,864,260 and are comprised of \$700,000 from Fund 402 fund balance and two (2) Board approved transfers from the General Fund in the amount of \$371,196 on June 7, 2016 and \$3,793,260 on December 13, 2016; and

WHEREAS, an additional transfer from the General Fund's Capital Assignment fund balance 001-3065 to Capital Projects Fund 402 of \$310,567 (\$5,175,023 less \$4,864,456) is required to complete the project.
